2. VIOLATION

a. Mi Pueblo International Market

Sales to Minor/3<sup>rd</sup> offense No Alcohol Awareness on Site

For the use of Mi Pueblo International Market, LLC

- Attendees: Miguel Delcid
- October 16, 2025, at approximately 5:58 p.m., a minor entered Mi Pueblo International Market. The minor, who was 18 years old at the time, attempted to purchase a can of Smirnoff Pink Lemonade. The minor reported that the clerk did request identification which was provided to them. The clerk looked at the ID and then sold the alcoholic beverage to the minor. Shortly thereafter, Frederick County Liquor Board Inspectors entered the establishment and cited the clerk, later identified as Alejandrina De Leon Marroquin, for the violation and noted that no employees inside of the establishment were Alcohol Awareness certified.
- Plea: Admit both charges

- Violation History: December 13, 2021 Unauthorized Alcohol 4 Day Suspension-April 28, 2022 Failing to have any certified Alcohol Awareness person(s) on-duty. Written Warning-October 11, 2023 Failing to have any certified Alcohol Awareness person(s) on-duty. No Contest Letter \$500 Fine, \$100 Admin Fee-November 27, 2023 Sales to Minor \$500 fine, suspended for 1 year probation. If another violation occurs during probation the \$500 fine is reinstated.
- **Timeline for NO Alcohol Awareness:**
- 4/28/2022 No Alcohol Awareness on this date 9/29/2023 Failed Sales to Minor Compliance Check, No Alcohol Awareness on this date 10/11/2023 Delivered Hearing letter for incident on 9/29/2023 No Alcohol Awareness on this date 10/12/2023 Delivered No Contest Letter for No AA on 10/11/2023 No Alcohol Awareness on this date

**MOTION:** Commissioner Burrel made a motion for a **Fine: \$1500** (increased due to being a second offense).

- **Administrative Fee: \$250**, payable within 24 hours of this hearing.
- **Mandatory Training:** All employees in the service of alcohol license holders must complete the Violation Prevention Class.
  - **Class Fee: \$200.**
  - **Class Schedule:** March 3<sup>rd</sup>, April 7<sup>th</sup>
  - **Completion Deadline:** April 7<sup>th</sup>
  - Registration for one of these classes must occur within 7 days of the hearing. Failure to complete training will result in a return to the Board for a hearing.
- **Probation: 2 years with the following conditions:**
  - If any new violations occur during this probationary period:
    - A **1-week suspension** will be imposed, with **no buy-back option**, but held in abeyance during probation.

**MOTION:** Commissioner Burrell made a motion for a **Fine: \$500 fine payable within 24 hours** of this hearing

- **As an added probationary condition if the establishment is found to be out of compliance with the AA certified staff there will be 3-day suspension imposed immediately, and a hearing will be scheduled before the Board**

**If any further violation occurs during probation:** If another infraction occurs during the probationary period, the suspension will be enforced immediately, and additional penalties may also apply.

**SECOND:** Commissioner Glass second the motions.

**FURTHER DISCUSSION ON THE MOTION:** Director Shugars explained staff's reasoning for recommending a \$1,000 fine for the failure to have alcohol awareness training on site.

Commissioner Burrell explained her reasoning for supporting a reduced fine for the absence of alcohol awareness training on site.

Chair Aquilino stated that she would not support the motion due to the reduced fine and reaffirmed her agreement with staff's recommendation of a \$1,000 fine

- Attendees: Christopher Watson, Laura Ferguson, Michael Stultz, Leeann Schregangost
- On October 30, 2025, at approximately 5:07 p.m., a minor entered Ruby Tuesday. The minor, who was 18 years old at the time, attempted to purchase a Bud Light. The minor reported that the server did request identification, which was provided to them. The server proceeded with the sale. Shortly thereafter, Frederick County Liquor Board Inspectors entered the establishment and cited the server, later identified as Danielle Fox, for the violation. Ms. Fox stated she did not possess a valid Alcohol Awareness certification for the State of Maryland. She explained that she is from Pennsylvania and was assisting the establishment due to low staffing, and that she only holds Alcohol Awareness certification in Pennsylvania.
- Plea: Admit
- Violation History: September 11, 2012 Not having a rule and regulation book on site during inspection Written Warning April 22, 2022 Sales to Minor \$500 Fine November 18, 2024 No Alcohol Awareness on site Written Warning, Compliance Check-Did not sell to a Minor October 9, 2024

**MOTION:** Commissioner Burrell made a motion for a **Fine: \$1500** (increased due to being a second offense).

- **Administrative Fee: \$250**, payable within 24 hours of this hearing.
- **Mandatory Training:** All employees in the service of alcohol license holders must complete the Violation Prevention Class.
  - **Class Fee: \$200.**
  - **Class Schedule:** March 3<sup>rd</sup>, April 7th
  - **Completion Deadline:** 6 months
  - Registration for one of these classes must occur within 7 days of the hearing. Failure to complete training will result in a return to the Board for a hearing.
- **Probation: 2 years with the following conditions:**
  - If any new violations occur during this probationary period:
    - **A 1-week suspension** will be imposed, with a **buy-back option**, but held in abeyance during probation.

**If any further violation occurs during probation:** If another infraction occurs during the probationary period, the suspension will be enforced immediately, and additional penalties may also apply.

- h. Monthly Violation Report Review
  - i. Director Shugars reviewed the monthly violation report with the Board and presented a summary of the civil citations.
  - i. Discussion and Possible Vote on Violation Guidelines
    - i. Director Shugars presented and distributed the proposed updates to the violation guidelines and explained to the Board the rationale for the proposed changes.
    - ii. Commissioner Burrell requested clarification on several items, and Director Shugars provided the requested clarification.
    - iii. Chair Aquilino agreed with the proposed changes and stated that, upon a third offense, the licensee should be required to appear before the Board.
    - iv. Commissioner Burrell raised a question regarding how staff would handle a third offense that occurs over a long period of time.
    - v. Ms. Keefer stated that a clear standard should be applied requiring any third offense to come before the Board, regardless of the length of time between violations. She noted that the Board would then determine the appropriate penalty, taking into consideration the time elapsed between violations.
    - vi. Commissioners Glass and Burrell asked whether the guidelines are published in the regulation book and available online. Director Shugars confirmed that the guidelines are public and published in the regulation book.
