Welcome and Introductions: Janet Vogel opened the meeting at 1:00 pm. Attendees introduced themselves.

Review and Approval of Minutes: Dr. Lee made a motion to approve, Leslie Barnes-Keating seconded the motion. All were in favor with no corrections.

Community Foundation Needs Assessment: Betsy Day, President and CEO of the Community Foundation, presented an Executive Summary of the Human Needs Assessment results, which identified the following three high priorities: supporting families with children, preparing for a growing aging population, and responding to substances use disorder. Local Care Team (LCT): Brooke Sims presented on the Local Care Team, a subcommittee of the Local Management Board. The LCT helps children with intensive needs, receive assistance with the identification of those needs, and suggest potential resources and services to meet the identified needs. Coming on the heels of this grant will be a 3 year grant, released in August, details are not available. There was a group discussion on potentially looking at comprehensive training so we all are using the same language and potentially considering bringing in training on becoming Trauma-Informed.
