The meeting was called to order at 10:00 am

1. PLEDGE OF ALLEGIANCE

2. PLANNING COMMISSION COMMENTS

Ms. Suarez mentioned that the Frederick County review of the Moderately Priced Dwelling Units (MPDU) Ordinance is proceeding. At a kick-off meeting, teams were established to explore improving on the current MPDU ordinance.

Mr. Rensberger welcomed Mr. Michael Sowell to the Planning Commission. Mr. Sowell will be filling the vacancy left by Mr. White as of July 1st.

3. AGENCY COMMENTS / AGENDA BRIEFING

Mr. Wilkins briefed the Commission on the upcoming July 8th meeting. There will be four Development Review items, including the Rutters project that was continued from the March 11th meeting. There will also be three legislative items; a Forest Resource Ordinance bill that is being discussed in today's workshop; a Zoning Ordinance bill, and a bill to amend the Zoning Ordinance on Accessory Dwelling Units that was recently introduced by the County Council. He noted that it again will be a virtual meeting, and virtual public input software will be utilized for any citizen who wishes to participate on any particular agenda item. One can go to the Division of Planning and Permitting's website to link to the specific meeting and choose from several options of participation.

Mr. Horn welcomed Mr. Sowell to the Planning Commission, and again extended appreciation to Mr. White for his 26 years of service to the County. He added that a more formal thank you would take place when the COVID-19 restrictions are lifted and gatherings can once again resume.

4. LEGISLATIVE BILLS

Bill 20-08 – Discussion of a bill to propose amendments to Chapter 1-21 of the Frederick County Code (Forest Resource) to increase forest conservation efforts.

Bill 20-07 – Discussion of a bill to propose amendments to multiple sections of Chapter 1-19 of the Frederick County Code (Zoning Ordinance) to update and clarify transportation, environmental resource protection, and historic preservation criteria on rezoning requests.

Ms. Mitchell explained that in the legislative process, the Planning Commission basically has an advisory role.

Discussion followed, focusing on examining the purposes of the bills and the reason they were introduced; asking questions of staff, so that at the public hearing, there will be more time to focus on public input.
