Introductions – Barbara May led the group through introductions of new participants and the organizations that are represented in the meeting.

ACEs Workgroup & We Design Updates – Pilar Olivo.

- Getting closer to bringing together stakeholders to apply for funding for a pilot expansion of the Universal Newborn Home Visiting Program in Frederick. The idea is to take the special delivery program and figure out how to create an evidenced based Family Connects model out of it.
- New guidance from FrameWorks for Childhood Adversity and Children Wellbeing. Updated the previously 15-year-old guidance to reflect the value of investing in children's potential as opposed to the idea of our community's prosperity.
- Working with FrameWorks to come back to Frederick to guide the approach to framing. Look out for the Webinar in May.
