Issues/events pertinent to the mission of the LEPC

- Sue Barthol DPW – No report
- Curt Luthye – American Red Cross
 - Introduced himself as the new Executive Director of the American Red Cross for Montgomery, Howard and Frederick Counties
- Dave Barnes Frederick Co. Fire and Rescue
 - The latest fire recruit class (Class #28) hits the street September 26, 2020. COVID friendly release, not typical graduation ceremony, will be held Friday September 25, 2020. Total of 21 new recruits
 - Recruit Class 29 – is scheduled to start shortly after the beginning of the new year
 - Training – modified training schedule to include small number of participants and big classrooms. Completing only activities for essential training, to include annual requirements and legal mandates
 - Gearing up for Fire Safety Education Month in October
- Kristie Dutrow - Emergency Communications – No report
- Kelly Cambrell - Public Information
 - Introduced herself as the new Public Affairs Specialist with the County Executive's Office
- Todd Johnson - Health Department
 - Shared Quote from Maryland Department of Health– Vaccines don't prevent disease, vaccinations do
 - This year both Flu and COVID vaccinations will be important to prevent illness and hospitalizations
 - Certain components of Critical Infrastructure groups will be targeted for COVID vaccinations to keep essential businesses and critical infrastructure up and running. More guidance to come
 - Frederick County Health Department is in its 34th week of Instant Management. Approximately 100 people running a full command of general staff with six branches and seventeen groups operational with support of contract tracing, case investigations, testing, PPE management, vaccination planning, supporting community partners in

their response and planning efforts, and enforcement of safe and community practices.

- Tracie Hanson – Homeland Security – No report
- Megan Galvin – Regions 1 & 2 Healthcare Coalition
 - Healthcare Coalition (covers Frederick, Washington, Alleghany & Garrett Counties) Function under Federal grant for emergency preparedness efforts in the region
 - Healthcare Coalition has secured a 3,000 square foot warehouse space in Cumberland, MD – looking in future to acquire PPE
- Milt Fritz – Brunswick Police – No update
- Robin Shusko – FCC
 - Introduced herself as the new Director Safety Security & Emergency Preparedness at Frederick Community College
- Dennis Dudley – Emergency Management & Emergency Preparedness
 - Have received funding for Hazard Mitigation Plan. Our current plan will expire in 2022. This provides us a little over a year to update, prepare and approved by the County.
 - Looking for participation of all our partners including the LEPC members to identifying risk and providing input for that plan. To include hazards and risks the county faces, provide for mitigation projects to reduce those risks
 - This plan will allow for municipalities and non-profits to apply for public assistance during emergencies and receive FEMA funding during the emergency.
 - Without a Hazard Mitigation Plan the county would not be eligible for FEMA funding
