Meeting Commenced at 1:02 pm

Introductions: Barbara May led the group through introductions of new participants and the organizations that are represented in the meeting.

Minutes: Pat Rosensteel motioned for a vote and was seconded by Delaine Welch. Unanimous.

FY23 IECC Co-Chair: Barbara May. She will be stepping down as co-chair in the Fall and a new co-chair will need to be voted on in June. Chairs must be from one of the representatives from the LMB, this can include the Health Dept, FCPS, COIPP, Head Start, DSS, Family Partnership, the Housing Authority, etc. If you are interested please contact Barbara.

CCC announcements: Patty Morison. The Children's Festival is coming along and planning is in full swing. Right now it will be held in the park and if it rains it will be held in the Tally Rec Center. The sound system is currently being refurbished and estimated to be complete by March 30, 2022. However, the Festival still needs support and are looking for more activity vendors for the Festival as well as volunteers or new committee members to assistance during the festival. Lastly, they are in search of an MC for the band shell. If interested or if you would like to volunteer, please contact Patty.

ACEs Committee update: Pilar Olivo. ACEs Adverse Childhood Experiences in Adolescence has been identified as a priority for health planning for the next 3-year cycle. They had a meeting to do a data review and identified what information they can use. Some areas include the Community Needs Assessment and Focus Groups; African-American women of child bearing age, Latina women, seniors, and families near the Waverly school area. They will be doing another logic model training to refresh and relook at the model that was developed in 2019. Planning on making updates for activities and outcomes/impacts that are envisioned for our communities. The County Executive announced that the Health Care Coalition will receive dollar to dollar funding up to \$300,000 to provide staff support and \$300,000 for three workgroups to implement in the next three years, with ARPA funding.

Logic Model presentation: Logic Model is complete, Jessica Lertora summarized the changes and will submit to the state.

Budget and Project Updates: Just finalized the year-end report for year 2 and it has been submitted to MSDE. The amendment for year 3 has adjustments for the Strategic Communications Consultant and promotional items for the Children's Festival. The promotional items for the Children's Festival can include early learning supplies and/or materials as well as copies or materials for the Childcare Conference.

Family Engagement/Native Content/FNP: The County Attorney's Office and Risk Management have signed off on the final template for the FNP Contest for the IECC Quiz. We have the contest rules and affidavit for winners to sign. We can move forward with the contest and fill-in the templates as needed.

Subgroup Selection: New subgroups are necessary since the nature of the groups have either closed/been completed, or on hold, or just need updates. It was suggested to look at the current strategic goals from the IECC and it was determined to have the following sub-groups:

1. Family Engagement/Native Content/FNP
2. Child Care Initiative
3. Relationship building with Businesses
