

RESOLUTION OF THE COUNTY COUNCIL OF FREDERICK COUNTY, MARYLAND

RESOLUTION NO. 22-44

RE: SUMMER 2022 WATER AND SEWER AMENDMENTS – CASE WS-22-13

Applicant: Division of Planning and Permitting (McFarland and Edgerly Properties)

RECITALS

Pursuant to the authority contained in §9-503 of the Environment Article of the Maryland Code, the governing body of Frederick County, Maryland has the authority to approve or deny amendments to the Frederick County Water and Sewerage Plan (“W/S Plan”) after a duly advertised public hearing.

Case WS-22-13 proposes the reclassification of two lots, totaling 2.2 acres, from W-1 to the Planned Service (PS) Water. The lots are identified as Tax Map 79, Parcel 147, Lot 28, Property ID number 09-221883 and Tax Map 709, Parcel 148, Lot 29, Property ID number 09-242368. The properties are designated Low Density Residential within the Linganore Community Growth Area and are currently zoned Agricultural.

The PS classification is assigned to properties shown on the Comprehensive Plan for growth utilizing publicly-owned community water or sewer systems, or within a Community Growth Boundary of a community to be served by public water and sewer in the County Comprehensive Plan, within the 11-20 year time frame. This classification may also be assigned if the property no longer meets the requirements of its current classification.


The County Council of Frederick County, Maryland, held a duly advertised public hearing on the proposed Water and Sewer Plan amendments on October 18, 2022, at which time the public had the opportunity to comment.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF FREDERICK COUNTY, MARYLAND that the following W/S Plan amendment requested in Case WS 22-13 is necessary and hereby approved: the reclassification of two lots, totaling 2.2 acres, from W-1 to the Planned Service (PS) Water. The lots are identified as Tax Map 79, Parcel 147, Lot 28, Property ID number 09-221883 and Tax Map 709, Parcel 148, Lot 29, Property ID number 09-242368.


