**Introductions:** Jessica Lertora led the group through introductions of new participants and the organizations that are represented in the meeting.

**Minutes:** Patty Morrison made a motion to approve; Diana Fulchiron seconded the motion, minutes approved unanimously.

Jessica reiterated that June – Oct will be in person meetings, November through May will be virtual

**Community Schools:** Kathy Allen.

- 5 locations: Butterfly Ridge, Lincoln, Waverly, Hillcrest (one more)
- Community schools will provide 1 stop access to medical and mental health needs
- Funding update: We are on target for funds. Pat will send Kathy information about a proposed amendment to spending

**Each One, Teach One.** Danica Warden.

- A program to teach young children social skills while participating in yoga and body awareness activities. Based on Cognitive Behavioral Therapy to help children focus on the moment and avoid impulsivity. The children also develop vocabulary about their emotions. Children develop Body Awareness (through the 5 senses), Body Ownership (Assertiveness and Spatial limits), and work on non-verbal communication. She offers 1 hour sessions.

**Networking:**

- Diana Fulchiron: Grants open on August 15. Impact grants are being accepted from Aug 15 – Sep 15. She also spoke about Catastrophic Healthcare needs grants to help cover medical expenses.
- Kathy Allen: Pre-K registration is open.
- Barbara May: Family Partnership will be offering Attachment Vitamins. This program is being offered two times a week at Head Start.
- Jessica Lertora: The Trauma Assessment is being conducted on the Court System as part of the Safe Babies Court Program.
