- Tanker Incident on Route 15
 - Call received at 11:55 am.
 - Fire Engulfed 514 Apple Avenue.
 - 508/510 Apple Avenue affected/fires.
 - Fire was out within 40 mins.
 - Clean up coordinated with MDE.
- Health Care Coalition reviewing draft radiation surge annex for regions I & II

- **Presentation: Zachary Zaykoski, MDE – Hazardous Materials passing through Frederick**
- **NRC Notifications**
 - **Incident Report # 1357231 Jan 8, 2023**
 - Caller reports that the SRP is dumping animal manure behind the building in the wetlands. The caller states in the past, they used to gather the waste and place in a dumpster for removal. However, the new renters are placing the manure in piles for the last 2 months. It is affecting the vegetation in the wetlands
 - Location Eyler Stables – 1141 Emmitsburg Road Thurmont, MD
 - **Incident Report # 1358083 Jan 19, 2023**
 - Caller reports the SRP is sand blasting and causing silica dust to fill the air. The caller states that this has been going on for years. They also paint and have an inadequate ventilation system that blows the paint directly out of the building.
 - Location Grables Commercial Painting 11726 Keymar Road Keymar, MD
 - **Incident Report # 1358915 Jan 30, 2023**
 - Caller is reporting a third party released an estimated 40 gallons of gasoline from a tanker trailer. Caller stated the release occurred when the driver of the truck went to open the valve of the tanker and the material released.
 - Location COSTCO 10 Monocacy Blvd Frederick, MD
 - **Incident Report # 1359935 Feb 13, 2023**
 - Caller reported a truck releasing antifreeze onto the going that threatens a drain if it rains
 - Location 11020 Peach Orchard Lane Brunswick. MD
 - **Incident Report # 1361450 (Related to #1361470)**
 - Caller reports unknown oil discharged from a tanker truck that was involved in a rollover (single vehicle accident). Caller states the truck caught on fire as a result of the accident and a house also caught on fire
 - Location 514 Apple Ave Frederick, MD – Route 15 & Apple Ave; Adjacent homes were also affected
 - **Incident Report # 1361470 (Related to #1361450)**
 - Caller is reporting that due to a traffic accident a tanker truck rolled over and caused a discharge of gasoline (8200 Gallons) onto the ground and into a storm drain. Caller states a fire was ignited as well, with a small explosion. There was on confirmed fatality with the incident to the tanker truck driver
 - Location US 15 Northeast County: Frederick 39.3939522 – 77.4462666 City: Frederick State: MD
