R-22-02 Cromwell Amendments to R-19-01 – The applicant requested approval of amendments to: (1) include a new 2.4-acre public use site on the Cromwell Property, a 160.8-acre Planned Unit Development approved in 2020, and (2) remove a condition stating that no building permits shall be used, except for model homes, until five years after the effective date of Ordinance 20-05-005 (November 10, 2020). The property is located on the north side of Old National Pike, east of Meadow Road.


