- The focus is on parents with young children.
- The planning grant asked what do families want? Survey of all 24 counties. Focused on families with income of \$50,000 or less.
- Quantitatively done- statewide focus groups, statewide analysis

- Five main areas- child care, transportation, housing, food security and health care
- Targeted universalism-go deep in one community and spread the information to the rest of the state.
- Focus areas: Baltimore City, Prince Georges county, and Somerset County (All have limited access to childcare)
- Parent leader advocacy sessions to empower parents.
- Funding will be provided by mid-October.
