

RESOLUTION OF THE COUNTY COUNCIL OF FREDERICK COUNTY, MARYLAND

RESOLUTION NO. 24-01

RE: FALL 2023 CYCLE WATER AND SEWER AMENDMENTS – CASE WS-23-15

Applicant: Frederick Wedgewood Minis, LLC

RECITALS

Pursuant to the authority contained in §9-503 of the Environment Article of the Maryland Code, the governing body of Frederick County, Maryland, has the authority to approve or deny amendments to the Frederick County Water and Sewerage Plan (“W/S Plan”) after a duly advertised public hearing.

Case WS-23-15 proposes the reclassification of 1.06-acres of land on Tax Map 86, Parcel 122, property ID #01-004204, located at 4981 New Design Road, from W-5/Dev, S-5/Dev to W-3/Dev, S-3/Dev. The property is designated Limited Industrial and is currently zoned LI, Limited Industrial. The property is located within the Ballenger Creek Community Growth Area.

The W-3, S-3 classification is assigned to properties designated residential, commercial, or industrial, or in general, a category other than Agricultural or Rural or Natural Resource on the County Comprehensive Plan, and where improvements to, or construction of, publicly owned community sewerage or water systems are planned within a 3-year time period.

The applicant has proposed that utility service will be supplied through an extension of an existing 8” private water service connection from a contiguous property under the same ownership and identified as Lot 30 of the Wedgewood Business Park subdivision. Existing public water and sewer easements will be abandoned as part of an addition plat that will merge the reclassification area with Lot 30 of Wedgewood Business Park. Additionally, any existing wells and septic systems within the reclassification area will be properly abandoned.


The County Council of Frederick County, Maryland, held a duly advertised public hearing on the proposed W/S Plan amendment on March 19, 2024, at which time the public had the opportunity to comment.


