FCPS Updates & KRA Data - [Link to Slideshow](#)

- un-embargoed and can be shared within school systems
- FCPS working to achieve 5 pillars of MD Blueprint model
- Studies show that children who attend PreK are much more ready for Kindergarten than children who do not attend PreK in many ways
- Year 2022-2023
 - 49 traditional PreK classes, 2 innovative in High schools, 4 half day 4s, 18 special ed and inclusive classes for a total of 71 PreK classes
- Year 2023-2024
 - 61 traditional PreK classrooms, 4 innovative classrooms in high schools, 25 special education and inclusive PreK classes (3s and 4s) for a total of 86 classes
- Year 2024-2025 projections
 - 58 traditional PreK classes, 7 innovative in high schools, 29 special education and inclusive classes (3s and 4s) for a total of 87 classes
- More children being identified with special education needs than in the past
 - child find is a year round process and those children get placed at all times throughout the year
 - For the 2024-2025 school year, morning 3 year old half days will be kids who are newly identified. They'll attend class M/T and W/Th
- Updates for blueprint
 - new early learning standards which include new age periods (young infants, older infants, toddlers, PreK3, etc.)

- simplified domains (SEL development, approaches to learning, language and literacy, early cognition and STEM, physical well-being and motor development)
- child examples and in practice teacher examples
- New assessment for kindergarten readiness
 - moving away from current KRA, independent analysis shows potential bias against multilingual learners
 - Currently in use - KRA (Kindergarten Readiness Assessment)
 - assesses skills learned prior to kindergarten, aligned to the early learning standards, administered between first day of schools and 10/10, mix of ways to assess (observational, selected response, and completion of tasks)
 - Demonstrating Readiness, approaching readiness, and emerging readiness
 - Families get ISR (individual student report) that shows scores and gives recs for things to do at home to increase skills
 - 50% rounded FredCo K students demonstrating readiness
 - 44% Maryland students demonstrating readiness
 - No significant changes in demonstrating readiness over the last couple of years
 - data shows that children with formal care before entering kindergarten perform better than children with informal care before kindergarten
- FCPS, as a whole, grew 10% in the last 2 years - the next closest was Carroll with 2%

ECAC Updates

- Received NOGA recently
- Timeline is not adjusted so expect that work will need to start right away
- Will need amendment ASAP as end of fiscal year is 6/30/24
- Some things in grant for Children's Festival and for the learning day

Children's Festival (April 27th)

- Flyer is finalized
- 2 children's champions sponsors this year: PNC and Family Connects with Frederick Health Hospital (meeting budget goals due to having 2)
- Exceeded \$4,000 in donations, expecting smaller donations to come in
- Now that ECAC grant has come through there is funding for YouTube video and vroom ring cards and other materials for families
- Currently have 13 booths - good number for this time of year, early bird deadline is April 4, expecting 60-70 booths total, applications for booths still being accepted
- All but 2 entertainment slots are booked, Judy Center @ Lincoln sponsoring Mr. Jon
- Family Connects celebrating birthday during event
- Everything on track but still looking for volunteers

Child Care Market Study

- County exec doing final briefing March 21 at 3:00 pm at Winchester Hall
- Finalization of project ideas and issue RFPs target date June 30
 - Selecting vendors and completing contracts by September 30
 - Project work begins by December 30
- Deadlines are tight and quickly approaching
- Conducting survey for community input
 - April 20 in-person convening with child care providers and families

- Local Management Board will now convene a workgroup to focus on childcare hopefully with members of IECC participating
- Website will go live after meeting on March 21

Partner Sharing

- PreK applications have opened, systemic announcement scheduled to go out 3/8/24
- Most recent state board meeting passed that school systems can implement sliding scale tuition for families over 300% poverty level
 - FCPS is waiving that sliding scale for 24-25
- Families need proof of address, proof of birth and income documentation
