Children's Festival Planning: Patty

The planning meetings will begin on January 4th. They will be held as virtual meetings on the first Thursday of each month through April, just before the IECC meeting (at 12:00) at MHA. Patty again urged the IECC members to get involved, since the festival is an IECC project. Pat suggested that a committee sign-up be placed in the IECC Google Docs so people can join in.

Updates and Networking:

- Child Care Market Study: Pilar & Shelly
 - The 3rd community input session (Business and Employer Focus) was held on December 6th. Mostly child care business representatives attended. Chamber of Commerce President, Rick Weldon, noted that a recent Chamber survey revealed child care to be the #1 barrier for employers, followed by transportation and compensation/benefits.
 - Pilar presented some findings from the Market Study. There is new data on the net social return on investment in child care. \$1 = \$1.78 (78% return) for center-based child care, and \$1 = \$1.45 (45% return) for home-based child care. The final report is due to be completed in February,
 - The Immigrant Families Focus Group is to be held at Family Partnership on December 13 & 14.
 - The 4th community input session (for families) is to be held at Waverley Judy Center on December 13th from 6-8 p.m. with dinner and limited child care
- ACEs Workgroup: Pilar
 - VROOM Partnership – The data access agreement with the Bezon Family Foundation is due to be signed by FCPS. We will be able to access the number of families who download the app and who actively use it (by zip code). Funding will be needed for rack cards for the Children's Festival and other uses. Materials are available in multiple languages.
 - Diaper Gap – The Ausherman Family Foundation has earmarked \$20,000 for the effort, which will make available 2 million diapers to the hospital at a reduced cost. Public distribution will be through the Rescue Mission's Food Bank, the Diaper Bank, and CareNet. Kathy will share with Pilar the distribution method promoted by the National Diaper Bank.
- Partner Sharing
 - Steve urged everyone to join a subcommittee!
 - The Kris Kringle Parade will take place on Friday, December 8th.
