## Alcohol Sales Compliance Check Update

**FREDERICK, MD --** Between September and November 2023, the Frederick County Board of Licensed Commissioners supported a Sales to Minor compliance initiative of 31 alcohol licensed establishments in Frederick County. Of the 31 licenses inspected, 19 sold alcohol to the underage buyers and 12 refused to sell. These violations have been adjudicated by the Frederick County Liquor Board. The hearing results can be found on our [website](#) via public minutes.

The Sales to minor compliance initiative aims to reduce youth access to alcohol. The compliance checks are conducted randomly at alcohol licensed businesses located in Frederick County. The program goal is to protect public health, welfare, and safety within our community.

These random compliance checks are a tool to identify retail establishments that sell alcoholic beverages to individuals under the age of 21. Compliance checks are effective in reducing underage retail access to this controlled substance. This sales to minor compliance initiative will continue to be conducted through 2024.

In Frederick County, underage volunteers assist in the execution of the compliance checks. All underage volunteers possess their valid, state-issued driver's license or identification card, which is provided to every establishment who asks for identification. If the server/clerk asks the individual their age, the volunteer is required to reply truthfully.
