EDUCATIONAL BULLETIN

1. **Inspections/Compliance Checks**-Inspectors will be making rounds again. Please make sure your new alcoholic beverage license, 2024 business license and Sales & Use Tax License are posted eye level for the public and inspectors to read. Compliance checks will continue to be conducted. Stay vigilant and inform your employees of your carding policy.
2. **Business License**- If you have not renewed your 2024 Business license, you are delinquent. Contact Kristy Hutzell (kristy.hutzell@mdcourts.gov or 301-600-1965) to renew your Business license.
3. **Tastings**-If you hold a Class A license with a Beer/Wine or Beer, Wine and Liquor Tasting endorsement, you must register your tasting events with the Board at least 14 days prior to the event. For your convenience, you can register your tasting events by using this online [Tasting Event Registration](#) form. Multiple tasting events can be registered at one time.
4. **Tasting with Distributor**-To participate in a tasting from a distributor, you must be the one responsible for purchasing the alcoholic beverages for the establishment. If you are going to be managing or on duty during or after the tasting, you **CANNOT** taste the samples. When doing a tasting from a distributor, it should **NOT** be done in the view of the public, so there is no misinterpretation of what you are doing. Use good judgement when making decisions to taste samples.
5. **Delivery**-If you have a delivery endorsement, you must complete a [Delivery Form](#) for ALL deliveries whether it is a delivery to an individual at their home or a delivery to an event. ALL delivery forms must be completed and signed by a person 21 years of age or older at the time of delivery.
6. **Special Events**-If you have been approved to hold a special event at your establishment, you need to ensure you are **CONTROLLING YOUR CONSUMPTION AREA**. Outdoor consumption areas must have barriers, and alcohol must be contained to these areas as customers cannot carry or walk away with drinks. As a reminder, employees cannot consume alcohol at these events or any time while on duty.
