- IIAA Code/Membership – The IIAA discussed reviewing the code for possible changes to the membership in-County residency requirement. Will discuss further, possible vote in July meeting.

- Member term update – Patrick Wheeler will be resigning his public seat effective June 30, 2024. We will be advertising in the Frederick News Post as well as on the FCG website. The next member term will be Emeka Enworom, set to expire June 30, 2025. He is eligible to serve his first full term if he chooses.
