- FCG Hotel Rental Tax – Task Order drafted and ready for IIAA vote.

Sue Johnson made a motion to approve Task Order #25-02, Frederick County Government Hotel Rental Tax, and issue to CLA, seconded by Nicole Prorock. All those present voted in favor (Steve McKay and Dr. John Molesworth absent). The motion passes.

Sue Johnson made a motion to approve, with an edit to the table of contents, the Internal Audit FY 24 Annual Report and to post as a public document, seconded by Nicole Prorock. All those present voted in favor (Steve McKay and Dr. John Molesworth absent). The motion passes.

- Status of RFP for 2025 contracts – Contractors have been selected and award letters sent out. The IIAA selected three contractors for this RFP process, SC&H, CLA, and UHY
- Audit Manual – Complete; need to verify all “yellow book” updates and links. No action is required, just for information and review.
- Meeting format to remain the same; virtual.
- Member term update – 1 public open seat; will be advertised in FNP and on County website under Boards and Commissions.
