

## **Rustic Road Cluster Nomination Form**

This form is intended for the nomination of a cluster of low volume, low speed roads in Frederick County that are considered “Candidates” for Rustic Road designation. The roads in the nominated cluster should be in proximity to each other and to several designated Rustic Roads. Together, they should create an interconnected network, interrupted by few moderate or high volume/high speed roads.

Ideally, a Rustic Road Cluster will be in proximity to a public facility with parking and restrooms.

Candidate roads in the nominated cluster that individually meet the criteria for Rustic Road designation will be reclassified as designated Rustic Roads if the nomination is approved by the Frederick County Council. All other roads within the defined cluster will retain their original classification.

Nominations for Rustic Road Clusters can be completed by County staff, the Rustic Roads Commission or any member of the public. Ideas of potential from the interested public are welcome.
