**EDUCATIONAL BULLETIN**

**2025-02**

1. **Inspections**-You may be aware that you are seeing our inspectors more often than before. It is the Board's initiative to perform, at least, quarterly inspections to every establishment. The following items will be inspected:
  - **Alcohol Awareness**- All alcohol awareness certificates (including those issued by the Liquor Board) shall be kept on file at the establishment and available for inspection.
  - **Fusion/Infusion of Alcohol**-If you are pre-mixing alcohol and storing it, the container must be labeled with the contents and date it was made. The mixed alcohol shall not be stored for more than three (3) days.
  - **Vendor Receipts**-Inspectors will ask to see alcohol vendor receipts. These records (either physical or electronic) shall be available for inspection. If they cannot be produced at the time of inspection, the receipts will need to be emailed to [LiquorBoard@FrederickCountyMD.gov](mailto:LiquorBoard@FrederickCountyMD.gov) within 7 days of the inspection.
  - **Patio/Outside Area**-With warmer weather on the horizon, Inspectors will be reviewing patio/ outside areas. Previous setups may have been acceptable to past inspectors, but it is necessary for the area to be properly secured, and adjustments may need to be made. If you are planning to add or update your patio/outside area, please reach out to the Board's office with a diagram for approval before making any changes.
2. **Compliance Checks**-Compliance checks will be conducted randomly at all licensed establishments every year. These random compliance checks are performed with an underage volunteer that possesses their valid, state-issued driver's license or identification card, which is provided to every establishment who asks for identification. If the server/clerk asks the individual their age, the volunteer is required to reply truthfully. **Beginning July 1, 2025, Inspectors may issue civil citations to the server or clerk that provides or sells alcohol to the minor.** The goal is to reduce youth access to alcohol and to protect public health, welfare, and safety within our community.
3. **Regulation Updates**- On May 12, 2025, the Board approved additions/revisions to the regulations. Most changes were updates from legislation that will be effective July 1, 2025. The Board also added regulations regarding **Civil Citations** and **Compliance with Frederick County Liquor Board**. A copy of the regulations can be found on our [website](#). Hard copies will be delivered by Inspectors during the Summer.
  - **PLEASE NOTE CHANGE: Class A Tasting Amounts (for those that hold Beer & Wine Tasting or Beer, Wine & Liquor Tasting Permits)**- have been revised for more consistent sampling amounts. Below is a list of what is allowed for tasting amounts, please see regulation §3.2 for the full regulation.
    - 6 total ounces of Beer, OR
    - 6 total ounces of Wine, OR
    - 1.5 total ounces of Liquor, OR
    - Any combination of Beer and Wine shall not exceed 6 total ounces, OR
    - Any combination of Beer and Wine shall not exceed 6 total ounces and 0.5 ounces of Liquor.
