

**Frederick County Board of Appeals**  
Meeting Minutes

Mr. John Greenwell, Chair, called to order the regular hearing of the Frederick County Board of Appeals ("Board") for Thursday, August 25, 2016 ("Hearing") at 7:00 p.m. in the 2nd. Floor Hearing Room in Winchester Hall, Frederick, MD. In addition to the Chair, present were Board members Mr. Mike Bowersox, Mr. Earl Bell, Mr. Tom Conard and Mr. Don Miller. Also present were Mr. Ken Farrell (Alternate Board Member), Mr. Michael Chomel, Senior Assistant County Attorney, and for the Community Development Division ("Staff") Mr. Larry Smith, Zoning Administrator and Mr. Craig Terry, Planner.

**Case**

**B-16-14      Eddie Mercer Agri-Services, Inc.**

The Applicant, as represented by Noel Manalo, Esq. of Miles & Stockbridge PC., Mr. Eddie Mercer and Mr. Andrew Brown with J. F. Brown III & Assoc., Inc., has requested a Special Exception to add additional agricultural products storage grain bins to an existing agricultural products processing operation located on the northwest side of Linganore Road (6900 Linganore Road, Tax Map 68, Parcel 177, Tax ID#13-301697, 151 acres) Zoned Agricultural (AG).

The Applicable Zoning Ordinance are:

- 1-19-3.210 Special Exceptions
- 1-19-8.334 Feed or Grain Mills

Mr. Terry read the staff report. Mr. Smith noted no agency comments. Mr. Noel Manalo presented his client's case. Three (3) witnesses spoke in favor of the Applicant's case while no one spoke in opposition. Based upon the evidence and testimony presented at the hearing the Board found that the request for the Special Exception did meet the requirements of the Zoning Ordinance Section 1-19-3.210, and Section 1-19-8.334. On a motion by Mr. Conard, seconded by Mr. Miller, the Board voted 5-0 to approve the Applicant's request
