5. **ZONING TEXT AMENDMENT**

- a) *Bill-19-09 Automobile Filling and Service Stations and Convenience Stores* – Amend Chapter 1-19 of the Frederick County Code (Zoning Ordinance) to update the Use Table (§1-19-5.310) to allow convenience stores in the General Industrial and Limited Industrial districts, and to add “convenience store” to the definition of Automobile Filling and Service Station.


