- **Introductions** – The meeting was called to order by Miriam Dobson and she started introductions of attendees.
- **Approval of Minutes** – On Hold until March 28, 2022 meeting.
- **FY23 Funding Discussion & Vote** – The FY23 Community Partnership Agreement NOFA has been re-issued with additional funding from the Governor’s Office of Crime Prevention, Youth, and Victim Services. Frederick County was allocated an additional \$65,288 in funding for a total of \$441,353.

Miriam discussed the recommendations proposed by the Executive Committee regarding how the additional funding could be utilized. Shelly Toms reviewed each of the proposed items and the Board had further discussion. Miriam Dobson motioned to vote, seconded by Leslie Barnes-Keating to fund the Getting Ahead program for 3 cohorts at \$30,000 and evenly divide the remaining \$35,288 between the four strategies/initiatives that have already been vote on for FY23 for a total of \$8,822 each.

After the vote, the board determined four areas that the programs should focus on with the additional \$8,822. These include:

- Transportation
- Mental Health Services
- Mentorship
- Work Based Learning
