Minutes of Meeting:

Welcome and Call to Order

Mark Long called the meeting to order at 2:33 and reviewed the virtual meeting protocols.

<u>Approval of Agenda</u>: With no changes, Hugh made a motion to approve the agenda. Assan seconded the motion. The agenda was approved.

<u>Approval of Minutes for November 9, 2021, meeting</u>: With spelling correction, Assan motioned to approve the minutes. Hugh seconded the motion. The minutes were approved.

<u>Business</u>

- 1. Recommendations of the Moderately (MPDU) Ordinance Workgroup -Ryan Trout
 - a. Presentation included background and explanation of MDPU and *payment in lieu* of (PIL) ordinance.
 - b. Hugh asked about excess value of units at resale going back to the County; Ryan responds that funds do not go directly to the Housing Department.

- c. Kim asked if the PIL fee tapers off over time; Ryan said that is not currently a recommendation.
- d. Assan asked how County manages the program; Ryan responded the program previously had an organizer but does not currently have dedicated staff for the program, but that it could change if the program grows.
- e. Malcolm asked how the new max purchase cap was determined; Ryan responded it was derived initially from income and applied to a formula.
- f. Mark requests the AHC take a **vote of support for the recommendations**. Malcolm makes a motion to approve the recommendations. Kandy seconds the motion. The motion passes unanimously.

2. Update on AHC meeting venue/format.

a. Mark reported meetings will remain virtual until at least April.

3. Motion to go into Closed Session

- a. Hugh makes a motion to go into Closed Session per General Provisions Art. § 3-305(b)(1) of the Open Meetings Act:
 - Specific Topic: To Interview an Applicant to the AHC and make a decision to Recommend, or Not Recommend, Appointment to the Affordable Housing Council. AHC members, and support staff, will go into Closed Session at the end of today's meeting.
 - ii. Kandy seconds the motion. The motion passes.
- 4. Presentation: First Time Home Buyer Program of the City of Frederick Dept. of Housing and Human Services, by Patricia Morrow and Steve Rose, Housing Counselors
 - a. Hugh asked about the number of people served; Patricia Morrow answered an average of about 20 -25 per class.
 - b. Ruth Waxter added the class is open to everyone.
 - c. Susan Brown asked for information on the New MD Homeowners Assistance Fund; Steve and Patricia gave details on the Fund.
 - d. Susan Brown asked about residence limitations; Steve and Patricia answer it is open to residents of Frederick County.
 - e. Kandy asked if attendees are allowed to retake the class; Patricia said people can retake the class, and the class certification expires after 12 months.
 - f. Kandy asked about the timing of attending class before/after closing on a loan; Patricia said they try to reach them before they go into closing but sometimes don't reach them until later in the loan process.
 - g. Malcolm asked about limitations due to COVID-19 and best way to access services; Steve said there are no current limitations to services due to COVID-19, and the best way to access the services is to call the Department. Patricia added that classes are currently offered virtually.
 - h. Another phone number was offered
 - i. Malcolm asked another question
 - j. Veronica Henry shared information and offered collaboration
