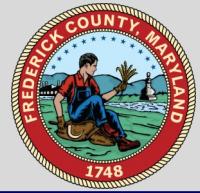

Furthermore, updated Trader's License and Sales and Use License should always be displayed.

### ALCOHOL AWARENESS!

The Board has adopted a new Alcohol Awareness regulation that requires 50% of ON DUTY employees that are SELLING or SERVING alcohol must complete Alcohol Awareness training.
