The meeting was called to order at 9:15 am

1. PLANNING COMMISSION COMMENTS

Mr. Hopwood had concerns about the aggressive schedule of these workshops; while realizing the timeline to complete the draft plan is crucial, Planning Commission members have other obligations and scheduling becomes an issue and fears having multiple meetings in one week, could set a precedence. Mr. Horn will coordinate with members to accommodate their schedules. Livable Frederick staff does distribute summaries of the work sessions and also suggest if members share comments with staff electronically, this may help keep meeting dates to a minimum but optimize time spent.

It was brought up that in the past, there were 'open house' events throughout the county where the public could view maps, information, etc. Mr. Dimitriou noted that this plan is not a parcel/map based approach; it is a document based plan. Mr. Horn added that once the Planning Commission has finished the plan draft, if appropriate, a town-hall/open house opportunity comes out for a 60-day review, then the document is recommended by the Planning Commission at public hearing. It was decided that this discussion would continue at the next meeting.

3. LIVABLE FREDERICK WORK SESSION


Mr. Whitaker opened with a video of what has been discussed, as well as comments, thus far on the four main themes:
