Project Types that may be considered for Combined Plan Applications in Accordance with Frederick County Code 1-15.2-5.1 include:
(1 required for submission)

- (a) Plat applications NO MORE THAN FIVE (5) LOTS, a common driveway, road layback, frontage improvements, utility work, or entrance/road widening improvements;
- (b) Bridge Repair and Rehabilitation Projects;
- (c) Road Widening and Repair Projects;
- (d) Minor Building additions *disturbing less than 1 Acre* of Total area;
- (e) Utility Projects which do not propose any additional Impervious Area
- (f) Certain redevelopment projects WHERE the SWM concept plan requirement to identify natural resourced could be with the SWM development plan requirements;
- (g) Residential projects consisting of 1 lot and disturbing less than 1 acre of total area; and
- (h) Projects designated as fast tract projects, based on criteria approved by Frederick County
