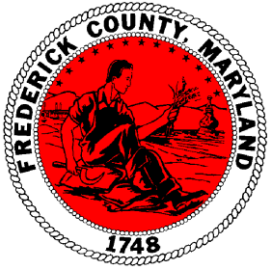

INDEPENDENT AUDITOR'S REPORT

We have audited the Senator William H. Amoss Fire, Rescue and Ambulance Fund for Frederick County, Maryland. Specifically, we examined the enclosed Schedule "A" Fire Protection Expenditures for the fiscal year ended June 30, 2010, and the Schedules "B" Disposition of FY 2010, 2009, 2008, 2007, 2006, 2005, and 2004 State Grant Funds as of June 30, 2010, under Public Safety Article § 8-101 through 8-106 of the *Annotated Code of Maryland*. The financial information contained in these schedules as well as compliance with applicable laws and regulations is the responsibility of Frederick County management. Our responsibility is to express an opinion on the schedules based on our audit.

We conducted our audit in accordance with generally accepted government auditing standards issued by the Comptroller General of the United States. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the schedules. An audit also includes assessing the accounting principles used and significant estimates made by management as well as evaluating the overall schedule presentation. As part of our audit, we also tested expenditures for compliance with the *Annotated Code of Maryland*, obtained an understanding of internal controls, and assessed control risk. We believe that our audit provides a reasonable basis for our opinion.

In our opinion, the schedules referenced above present fairly, in all material respects, the fire protection expenditures and the disposition of State grant funds of Frederick County, Maryland, for the fiscal year ended June 30, 2010 and for the fiscal grant years 2004 through 2010 as of June 30, 2010 respectively, in conformity with generally accepted accounting principles and consistent with Public Safety Article § 8-101 through 8-106 of the *Annotated Code of Maryland*.
