

Petition to Request Traffic Mitigation

A) [We] respectfully petition for speed or other traffic calming measures for the named streets and limits. B) [We] grant permission to the petition sponsor (hereafter referred to as "Agent") to act on our behalf through this process. C) [We] hereby release the county from and waive any claims we now or in the future may make relating to the proper installation of any traffic calming devices or solutions for which we have agreed to per "2nd Petition" approval (see #4 below).

Each person must read the following:

1. I understand that if our road/s qualifies, then 1 or more traffic calming device / measure may be recommended by staff. Each device may have advance warning signs and may be painted for visibility. A series of devices / measures may also be forewarned at each end with a sign reading, for example, "Speed Bumps Ahead / Next xx Mile."
2. I understand that it may be necessary to place the devices, measures, or signs in proximity to my house (generally at the property line) pursuant to the county's design criteria, and such that the overall desired mitigation is achieved.
3. The agent is responsible to prove that submittal of this petition constitutes a 51% majority of affected users (not just polled users). Any eligible residents / houses not solicited will be counted as negative responses.
4. I understand that if approval to install the devices is granted, then a "2nd Petition" will be required, said purpose being to accept the proposed layout that is ultimately developed by staff and the Agent. The 2nd Petition may be the same or different mix of names, provided that a 51% majority of the affected users (not just polled users) remains in favor. (Residents shall not sign the 2nd Petition until **after** the county has responded to the initial petition.)

Signature Sheet

For each house in the Boundary of Affected Residents list the house / apartment number and phone number. Exclude city and zip code except where requested since all zip codes should be the same. Only **1** "responsible party" per residence shall sign. If the respondents are not immediately available please set up the information to be answered later. Leave space as necessary to fill in later.

Note: "2nd Petition" is **not** intended to be solicited or initiated until **after** the original petition has been submitted to/accepted by the county.

1. In Non-HoA neighborhoods, that is, in neighborhoods where residents do not pay a participatory homeowner, or management fee towards a decision-making board, then a voting "boundary" must be established.
2. Because speed humps are more common, criteria is included herein. However, said criteria may serve as basic criteria for other physical mitigations too, with the understanding that specific criteria for size, shape, and design of devices like mid-block or intersection islands, chokers, road narrowing, et al, are independently available from the Department of Public Works.
