3. Approval of minutes: Jessica Fitzwater moved to approve the minutes and Mari Lee seconded the motion. Minutes were approved.
4. Sub-Committee Updates
 - a. Legislative
 - i. Jessica spoke about Karolyn Monroe drafting hotel training legislation.
 - ii. Explained the PG county legislation and how they're working with the HRC.
 - iii. They talked about asset forfeiture from trafficking cases and how other counties allocate funds back to survivor services.
 - iv. They talked about how FC might struggle with having 3 municipalities and how it would be difficult to divide up funds allocated to survivors.
 - v. They talked about the criteria for receiving funds and the generous juror fund that allows jurors to donate their compensation.
 - vi. The DLLR has no protocol and no unit that investigates human trafficking. They kick it to local law enforcement when they receive a case.
 - b. Community Response and Protocol
 - i. No significant updates. Malcolm and Heather presented to the Frederick County Coalition for the Homeless last month.
