## Sex Offenders Charged

As a result of ongoing monitoring of registered sex offenders in Frederick County, the Sheriff's Office in July has charged the following registered sex offenders with violating conditions associated with being placed on the sex offender registry.

**Christopher James Holte**, 34, of Frederick

**Charges:** Failure to Register as a Sex Offender (Failed to report for quarterly registration as required)

**Disposition:** Warrant issued on July 2, 2018. Arrested and currently incarcerated at Frederick County Adult Detention Center.

**Michael William Cullen**, 63, No Fixed Address

**Charges:** Failure to Register as a Sex Offender

**Disposition:** Warrant Issued July 11, 2018. Cullen has fled the state and may be in Massachusetts. Sheriff's Office is working with Federal partners in an effort to locate.

**Paul Iglesias**, 58, of Frederick

**Charges:** Failure to notify Sheriff's Office of a change of employment status.

**Disposition:** Criminal Summons issued on July 11, 2018. Mr. Iglesias has been served and is currently compliant with the Sheriff's Office.

**Samuel Joseph Klenke**, 40, of Ijamsville

**Charges:** Failure to notify Sheriff's Office of the use of a social media account.

**Disposition:** Criminal Summons issued on July 18, 2018. Mr. Klenke was served and is currently compliant with the Sheriff's Office.

**Gabriel Alicea-Rodriguez**, 37, of Frederick

**Charges:** Failure to notify Sheriff's Office of the use of a social media account.

**Disposition:** Criminal Summons issued on July 18, 2018. Not yet served.

**Willie Clark Jr.**, 60, no fixed address

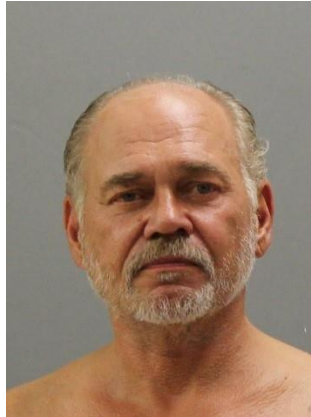
**Charges:** Failure to Register as a Sex Offender

**Disposition:** Warrant Issued on July 24, 2018. Mr. Clark is homeless and his current location is unknown.

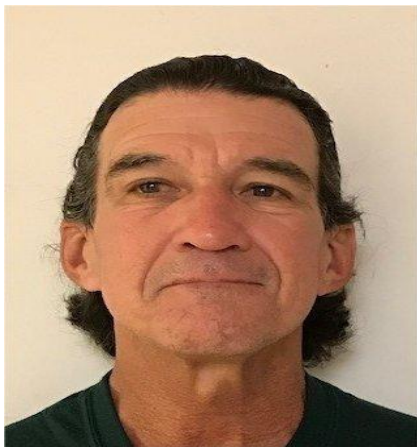

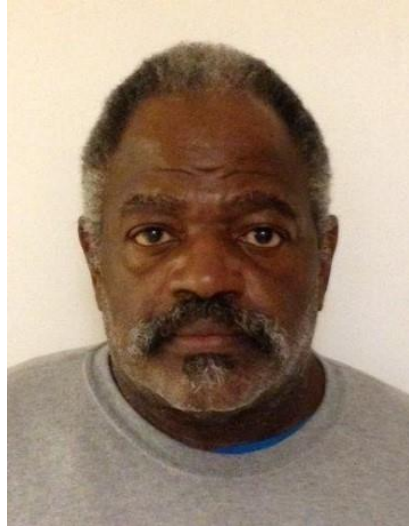
