This scholarship is based on participation in income based benefits programs, residency, and age, and will require the applicant to pay a portion of the program fee. Applicants must be 60 years of age or older and a Frederick County resident. Applicants must also be a registered participant at a Frederick County Senior Center. All information is kept confidential and treated with the utmost sensitivity. Due to class size limitations, please submit your application as early as possible but not later than 10 business days prior to the start of the exercise class. You will be notified by phone, email, or mail regarding the status of your application. Applicants will be registered for the program only after the application has been approved. If your application is approved, the applicant's cost for the class will be a minimum of \$5.00 for a single class pass, or \$10 for an all fitness pass. Payment is due within 5 business days of approval or prior to the start of the class, whichever occurs first. Participants must (re)apply every quarter and are expected to attend 75% of all scheduled classes unless illness or injury prevent attendance. Missing more than 25% may affect approval of future applications.
