#### Christopher Crossing Widening Project

To the Clover Hill residents:

RE: Interest in building a five foot sidewalk on the east side of Christopher Crossing

Dear Sir or Madam:

Frederick County Division of Public Works (DPW) is taking a survey of all residents in the Clover Hill community to determine the level of community interest in the installation of a five foot sidewalk along the east side of Christopher's Crossing as part of the current County Capital Improvement Program (CIP) project. This proposed sidewalk would be in addition to a 10-foot wide shared-use path that is planned for the west side of Christopher's Crossing. These improvements are programmed to be consistent with the County's Livable Frederick and Bikeways and Trails Plans that seek to provide improved mobility for non-motorized modes of transportation.

The 10-foot shared-used path will be maintained by the Division of Parks and Recreation as part of their bikeways and trails inventory. In the case of the sidewalk however, it is important to note that current County Code 1-15-4 assigns responsibility to the property owner adjoining the sidewalk to maintain it, including snow removal, repair or replacement. Changing maintenance responsibility would require a code change through legislation.

Please participate in this survey, located on the back of this letter. Your input is very important to the decision-making process for this project. If you do not respond with your input, we will assume that your preference is: "Scenario # 4 Do not build the sidewalk with no preference on maintenance and snow removal".
