Dear Planning Commission Members:

Envision Frederick County has read, reviewed and discussed the Livable Frederick Sugarloaf Treasured Landscape Management Plan (STLMP).

Overall, we are delighted with the focus on environmental sustainability, especially the conservation overlay proposed for the Sugarloaf Planning Area's boundaries. It is critical to protect the region's natural resources and ecosystem, which includes rare species and water bodies and forest cover that allows them to thrive. For this reason, the proposed conservation overlay restricting land uses to those appropriate to minimize adverse impacts of land development on forestland and natural habitat is a critical element and must be retained in the plan's approval.

We also request that you restore the area originally proposed for the STLMP, with the eastern side of the Plan boundary extending from the Montgomery County line along the west side of I-270 north to the Monocacy River and Monocacy National Battlefield, so that the overlay will protect this agricultural area from development impacts on water quality, forest cover and natural habitat.

The Plan's focus on environmental preservation is much needed for this area of Frederick County.

I join the Sugarloaf Alliance in doubting the Rodgers water analysis suggesting development is the best way to improve watershed health. Hi, Kim - on behalf of Stronghold Incorporated, could you kindly transmit the following comments to the Planning Commission. Please confirm the transmission.

Honorable Planning Commissioners - while Stronghold Incorporated appreciates yours and Staff's additional edits to the language of this Plan, Stronghold still has significant reservations about the implications of the proposed planning and zoning regulations in the Plan. The additional regulations and oversight likely will make operating Sugarloaf Mountain difficult, if not impossible. We would ask that you consider taking Stronghold Incorporated's holdings out of the Rural Heritage Overlay District and continue to explore a Euclidean zone particular to Stronghold.

In addition, we would request Maryland Department of Natural Resources review any applicable zoning provisions and provide you with feedback -- perhaps if you hear directly from them about the burden the Plan would place on Stronghold's mission, you might consider recommending further study and not advance a recommendation of this Plan.

I object to the proposal. My property is approximately 262 acres of land which runs along both sides of Park Mills Road bordered by the Monocacy River. After reviewing the draft of the Sugarloaf Treasured Landscape Management Plan I am concerned that the proposed zoning change on a portion of the property from A – Agricultural to RC – Resource Conservation will have a negative affect on the property values and future use. The current zoning already has similar classifications and should be left alone.

Also, the proposed conservation overlays for the area are not necessary as they stigmatize a property with burdensome regulations and have a negative effect on property values.

I am writing to request that the Planning Commission revise the Sugarloaf Development Plan to protect the property west of I270. Such protection is not possible if the Commission caves to the interests of local developers pressing their own private interests in making profits from their development. Their private interests need to be balanced against the interests of all the citizens of this county in preserving the historic resources of the community as well as the natural resources and the established interests of the property owners in this part of the community.

Frederick County needs to preserve the natural resources of the area for the health and well-being of its citizens. We

need places where we can refresh our connection to the natural world. This was recognized in the Livable Frederick Master Plan's Action Framework, which includes "Making Our Environment Vision A Reality: "...The natural environment and its habitat provision and ecosystem services are critical to our quality of life, and so they should be the primary consideration in all land planning and governmental decision-making processes." The Sugarloaf Plan should reflect and support these considerations. Development at Park Mills Road and Baker Valley Road in the Monocacy watershed would damage stream valleys and cause runoff, erosion, flooding and destruction of valuable aquatic life. And though we can add all of the new housing the developers want, we cannot then find new natural resources to replace those taken for development.

As important to the community's well-being is the Sugarloaf Mountain viewshed, both from the mountain and toward the mountain, which would be damaged by development near the natural and historic boundary of I-270. And the "hallowed grounds" adjacent to the Monocacy National Battlefield Park and the historic Hopehill community would also be irreversibly changed and must be preserved. The development plan would result in the "paving over" of these resources, subjecting them to stresses we simply cannot control adequately, nor replace. We are facing a global climate crisis and need to start making the "hard" decisions necessary to preserve what we have left that may allow a reversal of that crisis. In addition, we may need to adjust long-term to the health crisis of this pandemic. Having more outdoor space to be able to use communally is critical to maintaining our mental, physical, and social health. Continued rampant and unrestrained development of the past is living with our heads in the sand. Once developers have changed this landscape and made their

profits, they won't be available to fix the problems they have created. They never are. That genie can't be forced back into the bottle.

The original plan was created thoughtfully, over a long period of time. Space was set aside, available for preservation efforts. This new plan does not. It favors the few and powerful above that of the vast majority the citizens of Frederick County. It does so shortsightedly.

Restore the natural and historical Sugarloaf Treasured Landscape Management Plan boundary along the west side of I270 from the Montgomery County line north to the Monocacy River and Monocacy National Battlefield Park.
