Eligibility/requirements:

- The property must be your principal address for at least six months of the tax year, including July 1 of the tax year.
- The credit may be granted for up to five taxable years as long as you remain qualified. **You will need to submit a yearly application by April 1.** The credit is not available after the five year period.
- You cannot receive this credit and the Senior Tax Credit simultaneously
