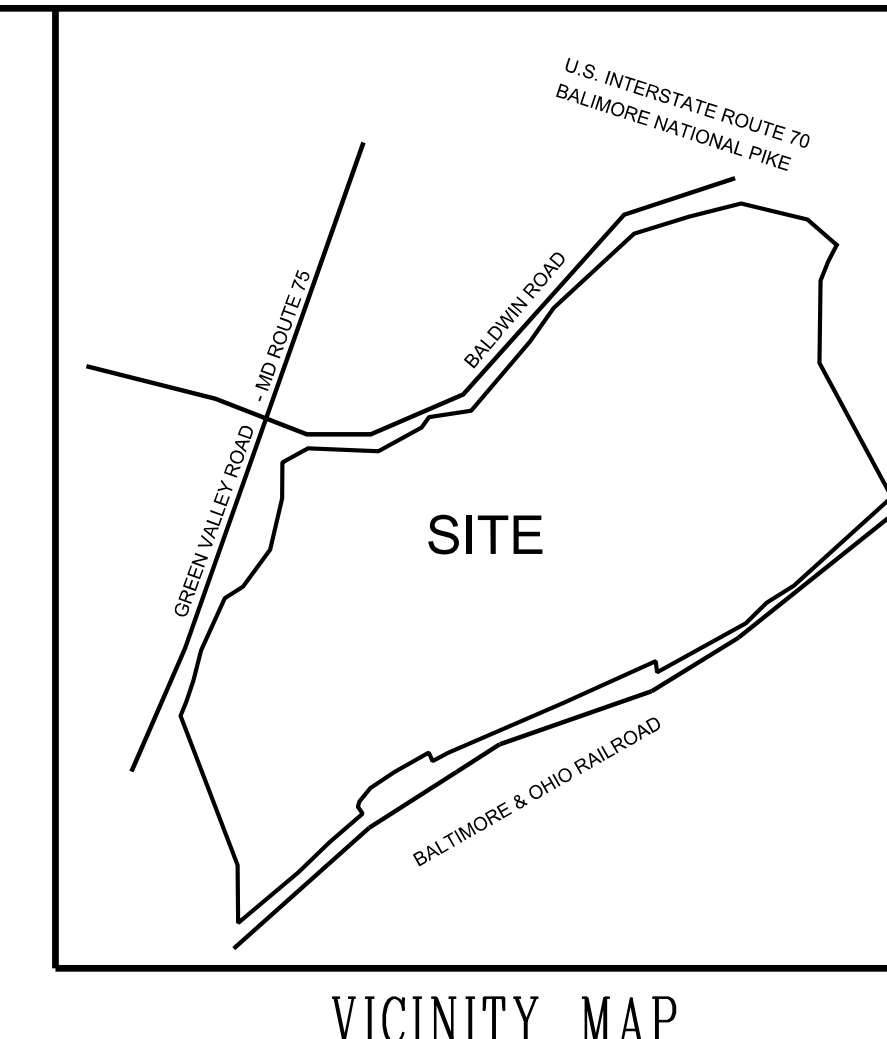
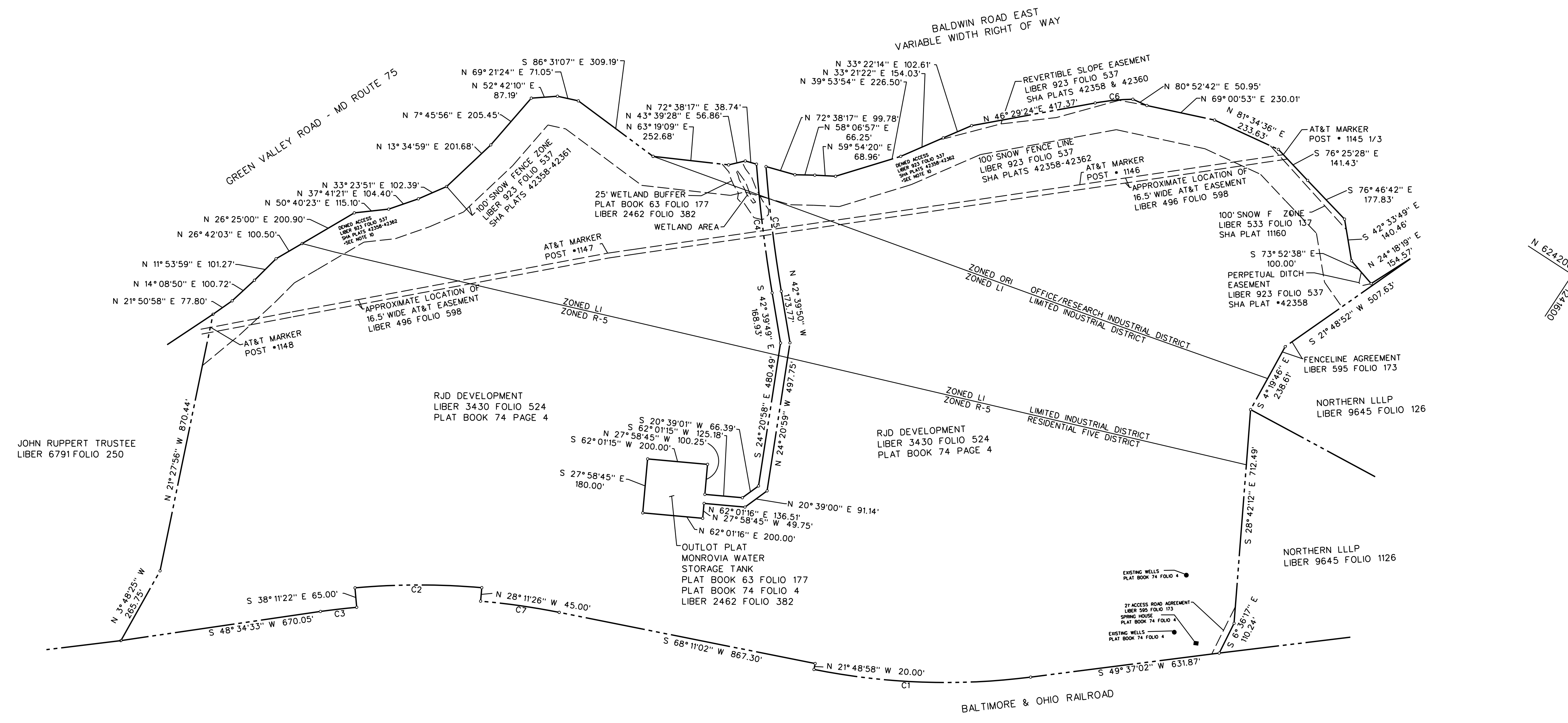

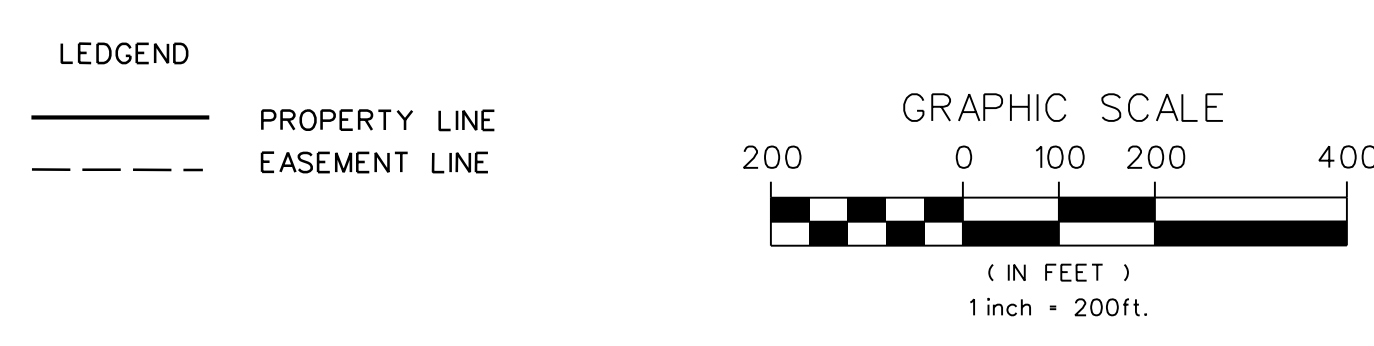
SITE NOTES

2. THE HORIZONTAL DATUM OF THE SURVEY IS ROTHENHOEFER ENGINEERS DRAWING No. 770-940.
3. THE BOUNDARY LINES SHOWN HEREON ARE FROM THE RECORD PLAT ENTITLED, "PROPERTY OF NEW MARKET ASSOCIATES" DATED OCTOBER 2002 WHICH IS RECORDED AMONG THE LAND RECORDS OF FREDERICK COUNTY MARYLAND IN PLAT BOOK 74 AT FOLIO 4.
4. THERE ARE NO PARKING SPACES ON SITE.
5. THE NAMES OF ADJOINING OWNERS SHOWN HEREON WERE TAKEN FROM MARYLAND STATE DEPARTMENT OF ASSESSMENT AND TAXATION RECORDS.
