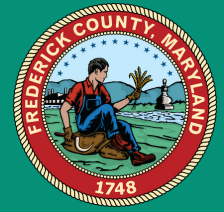

APPLICATION for \$75 Septic System Pump-Out Rebate

Please note: A property is eligible to apply for a rebate every five years.

The following items must be included with your application: (Do not staple documents.)

1. **Invoice from a licensed pumping company on the approved vendors list on our website.**
Invoice must include the address of the location serviced.
2. **Proof of payment for pumping service. Please submit one of the following:**
 - Cancelled check (front and back).
 - Credit card receipt for the pump-out transaction.
 - Invoice or paid receipt, provided by the hauler, showing that the account has been paid in full with no balance due.
3. **This signed, completed application form, including the information requested below.**

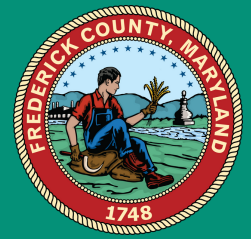

INSTRUCTIONS for Applying for a Septic System Pump-Out Rebate

Please read all instructions before submitting a rebate application. If you have any questions, please send email to: SepticRebate@FrederickCountyMD.gov.

- 1.** Was your septic system pumped after **JANUARY 1, 2022**? If so, continue to Step Two.
- 2.** Was the hauler who performed your septic pump-out listed as a participating contractor? If so, continue to Step Three. (The list of participating septic haulers can be found on our [website](#).)
- 3.** Properties are only eligible to receive a septic pump-out rebate once every five years.
 - If you have never received a septic pump-out rebate before, continue to Step Four.
 - If your property has previously received a septic pump-out rebate, please refer to the following chart to see if your next application window is open:

If you received a rebate for a pump-out that occurred between:	You will be eligible for your next rebate for pump-outs that occur after:
July 1, 2017 – June 30, 2018	July 1, 2022
July 1, 2018 – June 30, 2019	July 1, 2023
July 1, 2019 – June 30, 2020	July 1, 2024
July 1, 2020 – June 30, 2021	July 1, 2025
July 1, 2021 – June 30, 2022	July 1, 2026
July 1, 2022 – June 30, 2023	July 1, 2027

- 4.** If an approved septic hauler was contracted and it is time to apply for a pump-out rebate, the individual who paid for the service may now apply for a rebate. Continue to Step Five.

- 5.** Visit our website to complete your application online, or to download and print a form. www.FrederickcountyMD.gov/SepticRebate

A signed, completed application must be accompanied by:

- 1. An invoice from a licensed pumping company on our [approved haulers list](#).** The invoice must include the address where the septic pump-out occurred.
- 2. Proof of payment for pumping service.** Please submit ONE of the following:
 - Cancelled check (front and back).
 - Credit card receipt for the pump-out transaction.
 - Paid receipt/invoice, provided by the hauler, showing the account has been paid in full with no balance due.

PLEASE NOTE: ONLY THE ENTITY THAT PAID FOR THE PUMP-OUT SERVICE CAN APPLY FOR A REBATE AND SIGN THE APPLICATION FORM.
