Assisting With Energy-Efficient Upgrades for Moderate- and Low-Income Frederick County Residents



To submit this application, you will need:

- ☐ **This completed and signed form (pages 1 and 2)**
- ☐ **A retail receipt showing the purchase of eligible appliances. ***
- ☐ **Supporting documents to show proof of gross household income -**
 - Option 1: Provide a copy of pages 1-2 of prior year's federal income tax return for each adult in the home.
 - Option 2: Provide a Statement of Benefits or Financial Assistance for each adult. (Social Security, Unemployment, Section 8, etc.)
 - Option 3: Provide the four most recent pay stubs for each adult residing in the home.

Things to Know:

- Appliances must have been purchased within 90 days of applying for the rebate.
- The rebate will only cover up to 65% of the cost of the appliance purchased.
- Only electric-powered stoves, refrigerators, dishwashers, clothes washers, dryers and hot water heaters are available. No other appliances are included.
- Appliances must be new Energy-Star-certified models purchased from a licensed retail establishment.
- Used, second-hand, refurbished units and appliances sold by individual sellers are NOT eligible.
- Apartment units are not eligible for participation as the rebate recipient must be a utility/electric bill account holder.
- Each property address is eligible to receive one rebate for each type of appliance one time only.

Applicants must:

1. Reside on property in Frederick County, Maryland. (May be a renter or property owner.)
2. Reside in a home, townhome, condominium, mobile home, or duplex. (Apartments not eligible.)
3. Be the account holder/individual who pays the electric bill for the dwelling.
4. Have purchased eligible new Energy-Star-Certified appliances within the past 90 days. (This may include electric-powered stoves, refrigerators, dishwashers, clothes washers, or dryers.)
5. Have purchased new appliances from a licensed retail establishment. Refurbished/used appliances and items purchased from individual sellers are NOT eligible.

***ONLY THESE ENERGY STAR APPLIANCES ARE ELIGIBLE**
