Dear County Council Members,

I moved to Adamstown in Frederick County 24 years ago for its rural character. We bought a farm down the street from the now data center complex. Adamstown was known as a sought after town to live in because the area was surrounded by farmland, giving you the feeling of being away from the city, but close enough to all amenities in and around Frederick. The current Comprehensive Plan changes would remove hundreds of acres of preserved land from protection—a move that amounts to a speculative land grab.

1. No Data Centers Next to Homes.

2. Protect Preservation Areas.



Good afternoon,

As a child, I grew up in downtown Adamstown. I have fond memories of the yearly carnivals, firemen's softball games, bailing hay, and the farmlands. I still live in Adamstown and have obviously seen a lot of growth. No more carnival grounds, no more firemen's softball games, and disappearing farmlands. I work in the construction field, so I'm not afraid of construction and to a point..... welcome it. I wasn't a big proponent of the data center, but given all the options, it was probably the best choice. The growth that I have seen has been spread out over the entire county although, I am perplexed as to why it seems that Southern Frederick County seems to bear a sizable brunt of this expansion. The distance between Adamstown and Frederick has grown to such a narrow point that it seems Adamstown is now a part of Frederick. The narrowing of distance can be said for the northern town of Thurmont and the eastern towns of New Market and Monrovia. I'm not sure why there has been little to no expansion into the Middletown Valley, but that's a discussion for another time.

Having said all of this, I would like to make my opinion be made known that I am 100% against expanding the critical digital infrastructure overlay zone outside of the existing growth area. Furthermore, I am against redrawing any Rural Legacy Area or Priority Preservation Area lines period. There should never be any data centers or any industrial buildings next to homes anywhere with a setback of less than 2,640 ft. or ¼ mile.. We have lost so much of our protected lands that I feel it important not to sacrifice any more. Maybe an amendment that prohibits the redesignation of PPA's, RLA's or TLMA's would be a wise idea.

These guidelines were originally drawn for a reason: To Preserve the Ruralness of this picturesque community and to preserve the fertile grounds for any remaining or future farming endeavors. I humbly ask that the powers to be keep this in mind as they discuss this matter in the upcoming August 19th meeting.

Dear Council Members,

I hope this email finds you well. I am writing to express my deep concern regarding the proposed CDI Zone Ordinance (25-09) that will be voted on at the County Council's Third Reading on August 19, 2025. As a resident of Adamstown, I urge you to consider the long-term impact of this ordinance, particularly as it pertains to the siting of data centers and the preservation of our rural landscapes.

There are two critical issues that I believe must be addressed before this ordinance is approved:

1) No Data Centers Next to Homes

Data centers should not be allowed to abut residential areas. I strongly support an amendment to return to the County Executive's original protection as presented at the first reading on January 7, 2025, specifically prohibiting data centers from being located next to homes. As currently written, the ordinance allows for 500-foot setbacks from residential zones, but this does not go far enough to protect homeowners from noise, pollution, and other negative impacts. The CDI Zone Ordinance as it stands could lead to the removal of critical protections for Priority Preservation Areas (PPA), Rural Legacy Areas (RLA), and Treasured Landscape Management Areas. These lands are vital not only for the environment but also for the farmers and families who rely on them for their livelihoods. It is essential that an amendment is added to ensure that these lands remain protected from being re-designated for industrial use.

I believe that the land preservation laws in Frederick County should be respected and upheld. Allowing the rezoning of lands currently designated as preservation areas for data centers would have devastating consequences for the local environment, economy, and the people who live and work here.

I am a Frederick County resident and voter urging you to amend the CDI Zone Ordinance (25-09) to protect our homes, farmland, and preservation lands from industrial overreach. There are two changes I feel strongly need to be made.

1) *No data centers next to homes*

The County Council **must** return to the County Executive's original protection as presented at the First Reading on January 7, 2025. See *Siting Requirements to Apply to Critical Digital Infrastructure Facilities*, line 24 through 26, page 3., or similar language: (d) The track of land where the Critical Digital Infrastructure use is proposed may not abut land that is zoned residential or is designated residential on the Comprehensive Plan Use map.

Therefore, first, the CDI Zone Ordinance (25-09) should be amended.

- 1- to remove the setbacks, and
- 2- return to the restriction that data centers should not abut residential areas.

2) *Honor the commitment to protecting preservation areas.-- No sacrificing protected land to data center sprawl.* An amendment is needed to protect land currently designated as a Priority Preservation Area (PPA), Rural Legacy Area (RLA), or Treasured Landscape Management Areas for any such designated lands as of June 17, 2025. With this amendment, the land currently designated for preservation will be protected and the residents and farmers who live and work adjacent to the threatened land will be assured that their lives will not be turned upside down from data center sprawl. The residents of Frederick County deserve this peace of mind.

This is not just a policy issue—it is deeply personal. My children play in the cornfields behind my parents' home, the same fields generations of Frederick children have grown up exploring, nurturing, and growing up to inherit. These fields, and the peace and heritage they represent, could be lost to data center sprawl if protections are not strengthened. Once this land is gone, it is gone forever.

There have been copious reports of the harm these data centers bring, including the depletion of electricity in areas where they are built and the environmentally detrimental lengths power companies have to go to make up the difference. We can no longer afford to put our planet and our beautiful county at risk for the financial windfall of the few.

Good morning,

I live in Clarksburg, 18 miles from the proposed expanded CDI Zone. Having a data center near my home will result in the destruction of a prized rural area used by hundreds within the area and thousands of others from the surrounding parts of Maryland, DC, and Virginia.

I am writing to implore the Council to pass the proposed amendments to the CDI Overlay ordinance and ensure no data centers are built next to homes.

I am asking the County Council to return to the County Executive's original protection as presented at the First Reading on January 7, 2025, specifically:

(d) The track of land where the Critical Digital Infrastructure use is proposed may not abut land that is zoned residential or is designated residential on the Comprehensive Plan Use map.

Therefore, first, the CDI Zone Ordinance (25-09) should be amended.

- 1- to remove the setbacks, and
- 2- return to the restriction that datacenters should not abut residential areas.

An amendment is needed to protect land currently designated as a Priority Preservation Area (PPA), Rural Legacy Area (RLA), or Treasured Landscape Management Areas for any such designated lands as of 17 June 2025. This means that these lands cannot be redesignated out of these preservation categories during the Comprehensive Plan action currently underway for the purpose of placing the Overlay there. If this amendment passes the land currently designated for preservation will be protected and the residents and farmers who live and work adjacent to the threatened land will be assured that their lives will not be turned upside down from data center sprawl.

Allowing the sprawl of data centers is especially problematic when Visit Montgomery is working to draw people from all over Maryland, DC, and Virginia to this rural area with the promise of trails, green spaces, quiet, farms, crafts, and local food and drink. The data centers are in complete opposition to the desired branding of this and the surrounding areas.

Issues:

1. Why should the financial windfall of a few land speculators be more important to the council members than the welfare of their constituents?

2. The proposed CDI Zoning Map could be amended by any County Council in the future. What protection is there that a future map will not abut the village of Adamstown? Only returning the language to restrict data centers from abutting residential areas will relieve our anxiety and provide lasting protection.
3. A 500-foot setback is especially outrageous given that the council members voted to remove protection for the public from noise, vibration or pollution contained in an earlier data center bill. It removed complaint driven action, testing at the time of construction completion and prior to operation, changed reporting by the industry from twice a year to every two years and finally did not provide enforcement or fines for non-compliance with stated noise and vibration limits. The level of pollution from diesel generator testing is not measured or reported periodically.

I chose to live near Frederick County because of its rural character. An amendment is needed so that any Priority Preservation Area (PPA), Rural Legacy Area (RLA), or Treasured Landscape Management Areas lands cannot be redesignated out of these preservation categories. The Comprehensive Plan action currently underway is a specular land grab as it removes hundreds of acres of preserved land from protection.

Hello County Council Members,

I am a resident and voter in Frederick County and am concerned about the CDI Zone Ordinance (25-09). This bill will restrict data center development to tracts of land that are designated Limited or General Industrial and cap the total future size of the Overlay Zone to “less than 1% of the total land area of the County” – the equivalent of approximately 4,200 acres. As proposed, the bill would confine data center development to a single Overlay Zone in the Adamstown area that extends beyond the existing 2,200-acre footprint of the Quantum Frederick campus into tracts of land that are currently located in Priority Preservation and Rural Legacy Areas.

It is my opinion that expansion of data center development beyond the Quantum Frederick campus should wait until completion of a comprehensive study of the economic, energy, and environmental impacts of data centers. There are important unanswered questions about the future availability of adequate electricity and water for cooling needs and the impact of data centers on the County’s ability to meet its climate goals and renewable energy targets. I also agree with Mobilize Frederick to cap the size of the current Overlay Zone at .5 percent of the County’s land acreage (roughly the size of the existing Quantum Frederick campus).

Additionally, several of the tracts proposed for inclusion in the Overlay Zone are zoned agricultural and located in Priority Preservation or Rural Legacy Areas. Allowing rezoning of these tracts for future data center development undermines the goals of the County’s agricultural land preservation programs.

There should be no data centers next to homes. Therefore, I recommend that the CDI Zone Ordinance (25-09) should be amended to return to the restriction that the datacenters not be built in residential areas.

Also, an amendment is needed to protect land currently designated as a Priority Preservation Area (PPA), Rural Legacy Area (RLA), or Treasured Landscape Management Areas for any such designated lands. This means that these lands cannot be redesignated out of these preservation categories during the Comprehensive Plan action currently underway for the purpose of placing the Overlay there. I'm concerned that **in the current iteration of the Ordinance, there is insufficient consideration of the data center's damaging effects on the county environment and its residents, especially those who live near the facility.**

As written, the CDI Siting Ordinance (25-05) benefits the data industry at the expense of quality of life for the people of the county and has deleterious effects on the environment for the very long term. It sacrifices invaluable agricultural land which cannot be replaced. It allows unlivable vibrations, noise and pollution to infiltrate the homes and workplaces of people in the area without enforceable restrictions.

The way the bill reads now is misleading because if the Planning Commission and Council were to remove protected lands from established preservation areas, the Overlay as currently written would encroach on residential protections.

It is imperative, for the sake of the people of the county, that an amendment protecting the currently designated Priority Preservation Area (PPA), Rural Legacy Area (RLA), or Treasured Landscape Management Areas pass, so that this can't happen.

I urge you to ensure that 1) there will be no data center land abutting residential zones, and that 2) established protected lands will be permanently preserved.
