Dear Frederick County Council Members,

I am writing to implore you to keep data centers to an extreme minimum in Frederick County, limiting it to the Quantum Data Center. As a professor of ecology, I have been looking into the impacts and implications of data centers and what I have seen is beyond disturbing. There are very few permanent jobs created by building data centers, but the infrastructure is tremendously expensive and intrusive, and the environmental and social impacts are costly. The companies generally get a free ride with infrastructure provided by local taxes, and then the real problems begin. Water usage is highest at exactly the time it is most needing to be conserved: the hottest days of summer, for cooling the equipment at the data centers. In areas that are already water stressed, where people are asked to conserve and many on wells find they are nearly dry, we do not need an extremely thirsty data center in our midst. They also take a huge toll on the electrical grid, and may cause problems, again, on hottest days when air conditioners are running constantly, because they need to keep their equipment super cool. With technology advancing so rapidly, it is not even clear that data centers are what we will need in the next decade, and the vast infrastructural costs may not even be paid off before the realization occurs that there is a better way. Virginia local county executives fell for the ruse and now have to deal with rising electricity prices for their residents, where disconnect rates are rising because people just can't afford to pay their bills.

We should be inviting wind and solar to build infrastructure, for clean energy and enhancements of the power and security of our electrical grid. Instead, we seem to be inviting energy and water hogging data centers, somehow emulating Virginia's disastrous decisions to allow them in at epic speeds.

If the data centers do come in and raise our energy and water stresses, they will also add injury to insult to the people living closest to them, issuing noise pollution and air pollution from the diesel backup generators they have to rely on when power demands are higher than power availability. Let's not be Virginia!! Let's be Maryland Strong, and promote healthy life-giving capital projects, like wind and solar installations.

How can anyone in good conscience move forward with this without in depth environmental impact studies. Both the county and the state appear unable to effectively monitor and regulate environmental violations from the current construction. Since the start of construction the sites have violated over 100 major environmental violations. The space has been given "Stop Work" orders and there are **still** two ongoing Maryland Attorney General's Office investigations. The expansion based on this alone is more than enough reason to vote no.

The Planning Commission's recommendation was clear and responsible: keep data centers within the already-approved Eastalco footprint and do not expand the growth area. I strongly urge you to uphold that decision. This is not strategic growth. It's industrial sprawl that will permanently reshape our communities. These written comments are for the Public Hearing on Critical Digital Infrastructure Overlay Zone and Proposed Zoning Map Amendments on Tuesday, Dec 16, 2025 at 5:30 pm.

Dear County Council,

I am a lifelong resident of Frederick County, which is known for its biodiversity and rural, agricultural community. We reside in the Chesapeake Bay Watershed which includes habitat for thousands of aquatic, land, winged, and migratory species. The responsibility to preserve and protect this local land for future generations and North America's largest estuary falls upon each of us.

Data center developments have far-reaching impact, well beyond the property lines from which they reside. The CDI overlay expansion and rezoning should not be approved until the original, approved CDI site is fully operational and its impact fully evaluated.

Data centers may create over 8,000 new jobs and they may generate additional tax revenue, but it comes at a cost. Commute delays through Frederick are already burdensome, and with planned roadwork on US 15, this will only worsen. The current approved Eastalco Data Center complex will require extensive power, including electric and diesel generators. Proposed power line projects are slated to impact farms and homeowners throughout Maryland, and additional power resources may be required elsewhere in our county. Cooling requirements could strain existing water supplies for nearby communities. The current construction sites have incurred significant environmental violations, and future expansion will only increase water, air, and noise pollution.

From a research perspective, there is quantitative and qualitative data considered in any evaluation. Quantitative is 'measurable' and includes numbers and standards. It counts how many, how much, and how often. Qualitative is 'descriptive' and cannot be measured or counted as it is based on interpretation. Both quantitative and qualitative data are subject to bias. Bias may not be representative of the actual population or data, causing skewed data interpretation. Bias must be minimized to ensure accurate information is provided to constituents.

Like all communities in the United States, growth and change is inevitable; but a

controlled, pragmatic path forward is essential to preserving our local resources and communities. The stewardship of Frederick County elected representatives shall take precedence and remain committed to both preserving and enhancing the well-being of our community. Methodical planning and resourcefulness are essential to successful growth, waste management, and emergency response.

Please do not expand the CDI overlay area until the approved site becomes fully operational and environmental and resident impact assessment can be completed. Data centers are projected to have short lifespans, and the last thing Frederick County needs is more uninhabitable buildings or contaminated soil sites.

Council Members,

The vote you make this evening is important to you as well as to every individual in Frederick County, both those living today and those living in future years -- including those not yet born who will be voters who will be voters a few decades from today. Your vote will have lasting consequences. I have highlighted Brandon's words shown below because they express my opinion and recommendation exactly, and I believe are also the desire that is in the hearts and minds of dozens of other County residents.

There is no urgency to increase in 2025 the acreage designated for future data centers beyond those shown on the map recommended by the Planning Commission (PC) -- this can be done in 2026 if there is an **actual demand for future sites in the County** by firms that are ready to actually acquire a site here (and not merely by individuals who want to sell their property that lies outside of the PC's map). There are currently signs that the power shortage and high prices of future power and land in our County has reduced the relative attractiveness of sites here compared with sites in PA, VA, NJ, as well as in many states further south and west. So please wait to make potential sites available beyond those that are within the outer boundaries of the PC's map. The two firms who have Site Plan approval in our county have stated they are building structures on sites that will be available for data center operators to buy or lease.

I am urging you to wait until there is evidence that additional sites are actually needed.

Regardless of how we got here, the opportunity is yours to end this data center land grab now. You are the arbiters of what gets destroyed and what remains. I do not use the word destroyed lightly; these lands and environments will likely never get restored in my lifetime (I'm 39), and it's clear that the demand for them, at least for now, is limitless.

I know that you've convened countless working groups, heard endless arguments, and that you start each day with the best intentions to always do what is best for Frederick County. We do that too, not because we're elected, but because we've had this situation thrust upon us, and we want to right the ship and set it on a course that lasts beyond our lifetime.

You do have a choice. Data centers aren't solving world peace. They aren't a moralistic crusade. Data centers are about money, or at least the promise of it, and they chew their way through all of us as they come in.

What's best for Frederick County is to stop the bleed. If you care about what Frederick County is today, and what it has been up to now, then join the team that says no. It's not too late. We have a jersey with your name on it and we're ready to welcome you as local heroes. Be one of the informed, forward-thinking councils that doesn't bow to the endless pressure of greedy, reckless, short-sighted gain, and instead stand for integrity, equal representation, and long-term equity.

I am writing to urge the council to oppose the CDI overlay amendment and limit data centers to the currently approved Eastalco site.

I am a strong believer in carefully measured growth of projects that face public outcry locally accompanied by daily media accounts of negative data center impacts and attempts to legislate at the state, local and nation levels. This alone begs the question of a stepwise approach to growth. Will the project owner live up to stated expectations to protect the environment and the public? Project management best practices require milestones that must be met in order for further expansion of a new business line to mitigate risk and course correct as necessary, this is no different.

My house, 5600 Calvert Dr., is 500 feet from the proposed expanded CDI Zone which if passed would envelop my neighborhood and my son's school, Carroll Manor. My husband and I enjoy being active outdoors with our two kids. My son plays sports through Carroll Manor rec league and I help coach the Carroll Manor rec cross country team.

My family and I moved to our house 12 years ago mainly because it offered space for our family to grow and play unrestricted outside. The proposed 2,200 acre expansion of the data center campus will surround our neighborhood and Carroll Manor Elementary taking away our peaceful community, our enjoyment of the outdoors, and risking our health. There currently are no studies on the health effects of data centers and the backup generators that will be placed at each site, and yet the council wants to move forward against the wishes of the community and the recommendations of the planning commission.

I fear that if we continue to build without studying the effects on our health and the health of our environment that we are endangering our community and environment. We fear noise and light pollution, lower property values, higher electric bills, blackouts, a drain on local water sources, pollution of our well water, and damaging the serene beauty of the land. The environment (wildlife, air quality, and water) will be negatively impacted by the building of the data centers and the diesel backup generators that come with the data centers.

One data center site is already seeking a permit for 99 diesel generators that will need to run in order to be tested and maintained. If these diesel generators are permitted at all possible sites, we are looking over a thousand generators. So far, the Maryland Department of the Environment has not been able to answer questions such as, "how long will the generators be run weekly to test and maintain?" "Are we considering the combined impact of each site's generator on air pollution before we approve permits?"

We need to know what impact these generators will have on Carroll Manor Elementary School and the various sports programs run on the fields. Will the various sports teams that use the fields at the school such as (baseball, softball, soccer, cross country be able to have practices and host games or will our youth be breathing in harmful chemicals? Will our cross country team be able to host the 700 youth runners from across the state at their home meet when they are enveloped by diesel generators? Without clear answers, we cannot continue to build.

I am asking the council to consider

- 1. No data centers next to homes.**
- 2. Honoring the commitment to protecting preservation areas.**
- 3. Environmental Impact Studies be completed on the current building sites during and after construction to aid in future decision making.**
- 4. Enforcing backup power for datacenters that do not rely on diesel generators**
- 4. Protect Carroll Manor Elementary School and our children's health**

The Data Center Alliance of Maryland has a direct mail campaign around unproven assertions and a skewed “survey”. When all answers are positive and cannot be qualified (i.e. Likert scale which would ask for the level of agreement from 1-5 with any statement), when the sample is not representative of the population, and when we have no margin of error, **this is not a survey but a marketing trick.**

Mailers to Frederick County households feature stock photography of non-Frederick farmland and models posing as Frederick Data Center supporters. The last mailer we received claims without any proof from environmental or economic impact studies that:

- a. Data Centers at Eastalco will generate 40% of the County’s annual property tax revenue;
- b. Will use less than 3% of the County’s water supply; and
- c. \$12 million Data Center tax revenue has gone to farmland preservation. Certainly not in Frederick County?

After reading these claims, recipients of the mailers are encouraged to complete a “survey” (to be found here: <https://lp.constantcontactpages.com/cu/phLPH4i/frederickheritage>). This so-called survey is disingenuous and misleading. The first two questions ask for the zip code and whether respondents believe that Data Centers in Frederick will have a negative or positive impact. After that, only positive answers are provided, without any possibility of qualifying answers.

Question #3 asks what respondents think is the most important policy. The answers provided are: Requiring 5 acres to be protected for each acre used -or- dedicating 25% of the data center recordation tax to farmland preservation -or- limiting data center growth to less than 1% of the county.

Question # 4 asks which community benefit from Data Centers is most important to the respondent. The answers provided are: Funding education and school construction -and/or- funding agricultural preservation -and/or -funding parks and recreation – and/or- alleviating the county residents’ tax burden.

This is not a “survey.” Any “results” presented to you by the Data Center Alliance of Maryland must therefore be rejected.

Dear County Council Members McKay, Knapp, Keegan-Ayer, and Donald, Vice-President Duckett, President Young, and Executive Fitzwater,

I am writing to express concerns about the proposed expansion of the CDI zone.

In October, I attended a Frederick County Planning Commission meeting regarding the CDI zone. I was there to advocate against the proposed expansions to the zone. There we witnessed an enormous outpouring of opposition for the expansion of data centers' footprints in Frederick county.

I saw person after person stand up and beg, plead, threaten, and argue that the data centers' expansion won't be in the service of Frederick county. The reasons for the concerns are myriad, and I'm sure the other comments have expanded on them effectively enough, but they include economics, environment, ecology, health, community, raising a family, pollution, traffic, and many more. People asked not to be forced to live in the shadow of these constructions in a place they had called home, or be forced to leave.

I also watched people stand up in favor of the data centers, and the reasons were just one: Money. I watched property owners planning to sell, the construction company building the centers, and lawyers from Bethesda stand up and tell us we should allow these data centers to expand so that the speakers could make more money.

The Frederick County Planning Commission, in its wisdom, decided to recommend a minimal expansion of the zone. I would have preferred none, but still I'm happy with their recommendation, recognizing that the government of Frederick doesn't exist just for me. Now the proposal comes to you, and I'm asking you to accept the Frederick County Planning Commission's recommendation and keep the sprawl of data centers in Frederick as little as possible.

The economic benefits of these data centers, the only ones they offer, are not outweighed by their potential detriments - detriments that we know little about at the moment, but momentum nationwide and in Maryland is shifting against them. More and more companies abandon AI implementations. More and more jurisdictions create limits or require studies for data centers.

Lawyers for Microsoft's data centers have admitted that data centers don't bring long-term jobs to the communities they exist in, and that the entire purpose of community agreements is to convince people to accept these monoliths that offer nothing in return. Well, the community agreement that we want is the lack of a data center.

In exchange for what we don't want, we would have to lose hundreds of acres of farmland, the lifeblood of a nation. With food prices rising we need our agricultural land now more than ever.

The expansion of the CDI zone beyond the already accepted campus is unnecessary, and should be postponed. If data centers truly are a boon to our community, we will be supporting the expansion in the future. If they are safe and good neighbors, our neighborhoods will welcome them. Right now, they are unproven and not properly analyzed for their effects. In fact, thus far their neighbors are decrying them. If they want to expand, let them show that they can be a good neighbor with the land they have first. Please, do not include any additional land in the CDI overlay.

Good Morning,

My name is Joseph Anelli, I am an emergency manager who lives in Frederick, formerly the Emergency Operations Manager for Maryland Department of Health, among other roles. I've worked COVID, Ebola, and dozens of hurricanes and other natural disasters. I don't scare easily, but I have serious concerns about any expansions of data centers in Frederick.

1) Infrastructure

As far as I can tell, there's not adequate infrastructure in place for it. The power and water demands are huge - to the point where the recent mailers touted that the planned centers would use 3% of the county's water supply. That may seem like a small number, but when you consider it's for a single business park in a small area, it's actually a pretty insane number. A mid-sized data center used as much water in a day as 1,000 households. A single one of these data centers would create the utility demand of ten new neighborhoods in a much smaller footprint, and these plans would call for MANY of them.

In the rush to expand these data centers, my fear is that it will leave Frederick County residents with more power and water problems that we already have. My power already 'blips' out on a weekly basis, with short black-outs fairly regularly. More demands on power might make it difficult for me to work from home.

It would also drastically raise my home electric prices, just like it has everywhere else these data centers are put up, especially when they're installed quickly and haphazardly. I'm also deeply concerned about the effect on the water in this area. Frederick's water comes from a limestone aquifer and is already 'hard' (within a year at our new house our faucets were all covered with limescale build-up), and given these data centers would be downstream from us, I have concerns about the limescale sludge the cooling towers are going to leave behind, as well as the effect on the environment leaving a build-up of minerals will have.

2) AI Industry

This growth is driven primarily by a dubious industry need for power. Putting aside any of the other ethical and environmental issues surrounding AI (which are significant), the industry is very clearly in a bubble. None of the AI companies are profitable, and have been

spending huge amounts of money to make themselves seem inevitable, paying for it to be integrated into user products rather than companies seeking it out. And to keep up with this artificial demand, they need more data centers.

This rapid data center expansion is happening everywhere in the country. The hardware to fill the demand for these data centers won't exist for years, the infrastructure to support these data centers doesn't exist yet, and my fear is that the county will be left holding the bag when this bubble pops. If these data centers are truly necessary, they'll be just as necessary ten years down the line as they are today, and rushing to be the cheapest option for some tech companies that don't even have the logistics in place to actually fill the buildings with hardware yet isn't a winning long-term strategy.

Take your time, do it right, do not buy into the industry's hype. Let's see the *reality* of this goes (and not just the corporate promises) before we even think of expanding.

To Whom It May Concern,

I believe it would be advisable to limit the growth of data centers (including any overlay zone) until additional information is available to make an informed decision.

Currently there are concerns surrounding energy requirements and water requirements for these facilities. From an energy perspective, news reports indicate powering these facilities requires opening old nuclear power plants, running diesel generators, installing new power lines, etc. The environmental impacts alone raise significant concerns. As we are seeing worldwide, climate change impacts are devastating to communities – floods in Washington state, more frequent polar vortex's (<https://sebsnjaesnews.rutgers.edu/2024/02/how-climate-change-may-be-affecting-the-polar-vortex/>) , droughts in the American west, and some of our more divergent weather patterns in Frederick county (the extremes are more extreme than in the past including both flooding and drought).

Additionally, we are gradually losing our rural heritage to development of all kinds. Data centers will have an unusually large impact due to their need for power and water. To take tracts of land that are in Priority Preservation and Rural Legacy Areas undermines the County's agricultural preservation goals. The areas in which these facilities are allowed should be limited until the impacts are fully understood and available to the public as well as decision makers.

I'll also note that one of the reasons Alcoa shuttered the Eastalco site was due to energy cost. With more data centers over an ever-larger area, will energy costs go up for county residents? News reports would indicate that is what is happening.

It is also important to note that the recent survey from the "Data Center Alliance of Maryland" (<https://mdtechcouncil.com/data-center-alliance-of-maryland/>) and "powered by the Maryland Tech Council" (<https://mdtechcouncil.com>) mailed to county residents seeking to "gather community perspectives on the Eastalco data center campus in Frederick" is terribly biased. The survey asks three basic questions. First, is there a positive, negative, or no impact to Frederick County's rural landscape? Next it asks about policies on protecting rural landscapes and offers three alternative responses of

which none are true tradeoffs. And third, looking at County benefits that makes the assumption these benefits exist without any supporting evidence.

Before dismissing my assessment, please review the study Maryland Tech Council did for Prince Georges County (<https://mdtechcouncil.com/wp-content/uploads/2025/11/Sage-PG-DC-Impact-Report-Final.pdf>). They base their positive impact only on jobs created and tax revenue. While these are important, public health is as well. What is the cost to the public in terms of dirtier air, increased energy costs, and a host of other potential impacts? As I write this, the temperature outside is 11 degrees Fahrenheit. How many of our County residents can afford the electricity or oil to heat their homes?

From a different perspective, one could make the argument that if the data centers aren't built in Frederick County, they will be built elsewhere. That is not the decision here. The decision here is whether Frederick County's leaders make decision based on a full understanding of the impacts of those decisions.

There are several studies that should be completed prior to any expansion of the overlay area. First, what is the economic impact of the potential data center growth? It could be positive, but it could also be negative. Next, what is the energy, climate and environmental impacts? Any economic benefits or cost must be balanced against these impacts. Only when this information is available publicly can we all be informed on the best way forward to make an informed decision.

In conclusion, insufficient data is available to the public for a full assessment of the impacts of an expanded data center overlay. Until this data is available, the County should not expand the area available in the overlay zone.

- **Political Consequences:** The state legislature has rejected the approach of moving forward without data. For the County Council to reject the same principle signals a deliberate disregard for prudent governance and puts you directly at odds with the will of the state—and your local constituents.

I am very concerned about the impact of the already approved data centers, let alone the chance of increasing the number of data centers in Adamstown and further up New Design Rd and Ballenger Creek Pike.

I feel we are being manipulated and discounted. When will be informed about the true impact of these proposed data centers (the good and the bad)? The bad not until it is too late? I live in Adamstown since 1999, and did not receive any of the flyers about the benefits of data centers creating jobs and improving the schools (what are the benefits for Carroll Manor Elementary?) that a friend of mine who lives much closer to them. Is it because the flyers contradict what we were told when the Eastalco was sold for the purpose of the datacenters, especially the low impact to roads, scenery, white noise, etc.? These flyers indicate that the data centers will create 8,100 jobs for local workers during construction, and once they are fully operational, the campus will create 9,800 permanent jobs from skill trades. How can this be managed? How are our roads going to handle that many jobs? We were told that there would only be about 19 people in each building (shift work) and would not impact the roads and of course where is our beautiful landscape. Frederick roads can't handle the amount of traffic now. When I moved here in 1999 and worked in Frederick (7 miles away), I may have passed 1 or 2 cars going to work on New Design. By the time I retired, it was heavier, but now, no matter the time of day, traffic going in both directions is unbelievable and dangerous. Trucks and other vehicles ago down the road taking up more than there lane, And this does not include Ballenger Creek Pike, Buckeystown Pike and Rt. 15. I could go on and on....

My name is Caroline Dato and I am a citizen in Downtown Frederick, District 4. I am emailing in regards to the proposal to expand the zone for data centers in Frederick county. As a tax paying citizen who has worked within Frederick County for over four years, I am deeply concerned about any data center expansion. I urge you to reject this expansion, which will have massive ramifications for the economic and environmental health of the residents of our beautiful county. One of my favorite parts of living in Frederick is the diversity. Within the span of 15 minutes, I can drive from the bustling city of Frederick, to the beautiful rolling hills and farmlands of Adamstown. I can shop at farmers markets in the summer, pick pumpkins with my family in the fall and purchase a Christmas tree in the winter. All from local farms whose livelihood depends on the land they own and community support. With the proposed data center expansion, over 1,000 acres of prime farmland in Priority Presentation and Rural Legacy areas could be lost. The beauty of our county, including the farm lands and those who work on those farm lands, MUST be protected.

Data centers wreck havoc for the working class citizens in which they operate while filling the pockets of those who lobby for and build them. Most jobs that are "created" by data centers are low-paying and inconsistent, while the environmental impacts are vast and long lasting. I request that you follow the recommendations of the Frederick County Planning Commission when you vote on the overlay map. There are so many unresolved financial and environmental concerns that have been raised in the long-running discussions about data centers in Frederick, but I believe the Planning Commission has presented a reasonable path forward after carefully considering the many factors brought forward to them by opponents *and* proponents of building data centers in Frederick County.

In a year or so, the State will have conducted a study of the pros and cons of data center development in our State (Sen. Bill 116), and we'll have more information about how the data center business is doing nationally, and here in Frederick.

We've committed to building at least some data centers in our County, and the number of acres that will be devoted to that enterprise is already significant. **Let's tread carefully and gather knowledge that we can build upon, and then decide to allow for more acreage *if* it's warranted.**

Comments, Part 2

I raised the issue of electronic waste in a Planning Commission hearing, but want the County Council also to have this issue in mind going forward, as regulations for data center developments are formulated.

I've been interested in waste policies for a number of years, and like most people am aware that e-waste is a monumental problem in the US and world-wide, and not one we as a society have dealt with very well. The research I've done on e-waste generated by the data center industry is sobering, because the magnitude is so great.

There are companies who assist data center developers with handling e-waste, with a lot of variation in how sustainably they handle it. Some e-waste ends up overseas, or in landfills, but some is recycled or reused. Because there really is no federal regulation of this waste, and limited state regulation, especially for a data center-level of e-waste, it will be up to the County to establish good policies.

I recently had a pleasant conversation with Michael Kuykendall about the e-waste problem, and while he acknowledged that it is a considerable problem, his company is not the responsible party, when it comes to properly dealing with the e-waste produced at the Catellus-owned property —

that will be up to the companies operating the data centers, like Amazon. Can we trust them? Kuykendall was open to receiving information about good plans and regulations for e-waste, but so far, my searches for such information haven't yielded very much.

Here are some excerpts from articles I've read that will give you a sense of the problem.

Excerpts from a Clean Energy Leadership Institute (CELI) article in December 2024:

"While discussions about data centers' energy consumption and environmental impact are widespread, far less attention has been given to the mounting problem of electronic waste (e-waste) generated by these facilities. **Servers and GPUs, essential to data center operations, are typically replaced every 2-5 years, producing millions of tons of outdated equipment — more than 80% of which is discarded.** A recently published Nature study warned that generative AI alone could contribute an additional 1.2-5 million tons of annual e-waste, posing serious environmental and health risks globally.

E-waste recycling and handling are poorly regulated, with limited infrastructure to support circular practices. Privacy and security concerns often prompt companies to destroy outdated hardware rather than reuse or recycle it. Addressing this growing issue requires a better understanding of its scale, societal impacts, and systemic gaps.

.....

In the U.S. ... no federal regulations govern e-waste management. Although 25 states have some form of e-waste legislation, these laws vary widely, with only 16 states banning e-waste from landfills.

.....

E-waste is hazardous, capable of releasing up to 1,000 different chemical substances during improper disposal or recycling. In developing countries, where much e-waste is dumped or handled, workers are routinely exposed to contaminants such as lead, mercury, cadmium, and arsenic. These chemicals can cause cancers, miscarriages, and irreversible neurological damage."

Excerpts from an online article on the NCS Global website, May 2025:

"Data centers are the backbone of modern digital infrastructure, but their rapid hardware refresh cycles contribute significantly to global e-waste. Racks, computing equipment, monitors, circuits, and other electronic components within data centers are often refreshed on cycles as short as three to five years.

A recent study published in Nature Computational Science estimated that, with the advent of generative AI and its associated computational resource consumption, the amount of e-waste generated could potentially reach a total accumulation of 1.2-5.0 million tons during the decade of 2020 through 2030.

.....

Improper disposal of IT hardware leads to hazardous waste in landfills, contaminating soil and water with toxic chemicals. According to the United Nations, e-waste is the fastest-growing

waste stream globally. Data centers must implement sustainable IT asset recovery services to reduce their environmental footprint.”

Are Data Centers Bad for the Environment?

Data centers produce all kinds of e-waste. Whatever the type, it impacts the environment negatively in at least two ways: equipment disposal, and data center energy consumption. And the equipment disposed of often isn't according to best practice.

What kinds of e-waste components that need recycling are used in Data Centers?

Data center networking equipment

These devices facilitate communication and data transfer within networks. Their primary function is to manage and direct data traffic between different devices and systems. Examples include routers, switches, firewalls, load balancers, and network cables.

Server equipment

These are powerful computers designed to process endless requests, store data, and run applications 24/7. They are the workhorses of a data center, handling computational tasks, as well as storing and handling large amounts of data. Examples include web servers, database servers, application servers, and file servers.

Other data center equipment

This includes everything else that is contained in data center architecture. There are monitors, computing equipment, circuits, and any other electrical components within the infrastructure. Examples include storage systems (like SANs and NAS), power distribution units (PDUs), uninterruptible power supplies (UPS), cooling systems, and racks to house all of the equipment.

In the articles above, some solutions are offered, but as discussed in the articles, these solutions require vigilance by the developers and operators of data centers, oversight from governments, and the best solutions are expensive.

What is the plan for the data centers in Frederick County to deal with their e-waste? Until we know what the plans are, and how they work (or don't) for a period of time, it would be wise to be cautious about data center development, and that's why I support the Planning Commission's recommendations regarding the CDI Overlay map.

Dear Council Members of Frederick County Government,

I have been living in the Green Hill Manor development in Adamstown since 2001. This letter is being emailed to you to voice my concern over the data centers being constructed in this area.

I was fine with the original plans using the contaminated East Alco property but am now very concerned with the expansion of these data centers. I do not see any regulations of these plans, only efforts to change restrictions to make it easier for more data centers to be built. Sounds like the goal is 26 data centers each of the size of a football field. **Focusing only on the potential money this may bring to Frederick defies common sense.** These structures should **not** be allowed close to residential, school areas or roads. Would you really want this next to your home? The data centers should be north and west of the railroad tracks to give the residents, churches and Carroll Manor Elementary school buffer from the impact of these massive structures. Preservation land should be protected as well. I hope that you will be **in favor of the planning commission recommendations.** It is such a shame how Adamstown could become Data town! This expansion will forever change the landscape and feel of this area and not for the better.

Based on what I have been researching, there has not been any impact studies being conducted. The use of water to cool this data system is concerning. If there is a drought, which occurs often in this area, are they going to have to adhere to water restrictions like us residents? The only other option to cool this data center is air, and then it becomes extremely noisy.

What about the use of energy? These buildings need massive amounts of energy to run efficiently. Right now, it seems they do not even have a plan to power the centers currently under construction on the East Alco property. Now they want to expand. It makes no sense to me. If they need so much power, why not put solar panels on all the building roofs and have a battery backup system too. That way maybe data centers would not need to run the diesel generators as often! **In addition, the data center permit article says they can operate the generators up to 50 hours per calendar year under non-emergency conditions, with no limit on emergency operations. Please tell me who decides when an emergency will exist? This is very vague; they can call anything emergent and run them as long as they want!**

The community here in Adamstown is not getting the answers to alleviate their concerns. I feel we are being dismissed. Residents here work very hard for their homes and

community and are concerned about their quality of life. At the end of our day, we want peace in our community. Twenty-six data centers will be eyesore, make noise and potentially pollute the air. The welfare of your constituents should be your priority.

Finally, planning to have a final vote on this overlay two days before Christmas is wrong.

Dear Council Members, I read this morning on Councilman McKay's Facebook that he plans to propose an amendment to exclude the Noffsinger Property. I am disappointed by his position but I thank you nonetheless for supporting the inclusion of the Noffsinger Property (and subsequent rezoning) into the CDI Overlay. Please explore the history below so you can see what a long and continued struggle this has been for the Noffsinger family in many, many ways. Attached is a signed letter of support from their family to have the farm and houses included in the overlay and to be rezoned. Please help them!

Mrs. Lois Noffsinger raised her 5 children (David now 60, Jim now 58, Dan now 57, John now 55, and Dolly now 53) on the family farm where her husband (the children's father) was tragically killed. A painful and lasting memory.

Mrs. Noffsinger gave each of the children a lot to build a home (now zoned AG), to get them to stay on the farm.

The farm property has been zoned GI for many years and also houses John's welding business.

The property is located between the Stanford Industrial Park and Agro Industrial Park and has a comp-planned road dividing their farm into two pieces.

Four of the children constructed homes and raised their children on the AG lots at the front of the farm, and one lived in the old farmhouse and held an undeveloped lot.

In 2017, Mrs. Noffsinger asked me (Charles Seymour) to start working with her and her family members, to dispose of the family farm. The farm had been placed in a Trust and she gave me instructions to plan to liquidate. She explained that she didn't want her children to argue about selling the farm or about money after her death.

The farm was placed on the market after it was site planned for 11 industrial lots and after tremendous engineering and other expenses. The property was being explored by several industrial users at that time.

Around 2019, Mrs. Noffsinger fell ill and was placed into an assisted care facility. We continued to have regular communication, and she expressed her desire to expedite the process to liquidate the property prior to her death. Her children David and Dolly (Trustees) expressed the need to sell half of the farm in order to cover debts and to be able to keep their mother in nursing care, which was exceedingly growing in cost as her health continued to deteriorate. The sale would also help with their family relocations to other properties, after a final sale of the remaining lands.

To accommodate her request, I helped sell 60 acres (the Northern portion) of the farm where the comp-planned road divided the property, leaving about 40 acres of the GI zoned land and the 5 lots with 4 homes zoned AG.

On October 18th, 2021 the 60 acre portion of the Noffsinger Family Trust land was sold/settled.

On October 20th, 2021 Mrs. Lois Noffsinger passed away.

During this time, as you know, senate Bill 397 had changed the dynamic of GI land, and the Noffsinger land was included as a property being marketed for a potential future Data Center by Frederick County Economic Development. As part of that sale, the Noffsinger children began the process of relocation, not wanting to be in the middle of industrial development, but mainly because their lives all changed after the death of their Mother. Unfortunately, the Noffsingers have been delayed in the final sale process for years now, causing them real economic and emotional hardship. The Noffsingers each purchased relocation properties in Frederick County, believing that their remaining lands would soon be sold. However, they have been trapped by moratoriums and the "overlay" discussion, which has changed their ability to complete the final sale of the remaining land, which they had financially counted on for their relocation. They have been through years of hearings and hurdles while they have watched their future dreams evaporate. These delays continue to plague them financially and emotionally. They have tried to move on with their lives, their children's lives, their equipment, their businesses, their cattle, and their legacy, all based on the early approval of Data Centers in GI land and APFO approval of the sold portion of their farm.

The Family Trust is unable to be closed due to these delays. Taxes continue to accrue as do other expenses with legal, accounting, maintenance, etc. Monies are unable to be distributed, and the family is unable to fulfill their remaining life plans.

As you can imagine, each of the families' spouses and children are being impacted as well. They were committed to a well crafted land disposition plan, but have had only turmoil for the last 4 years. The Noffsingers are not big developers, they are simple hardworking people. Please allow them to complete the sale of their remaining lands and support the rezoning of their homes and the inclusion of their land into the CDI Overlay. Please see the attached letter. This letter is in response to your zoning verification application submitted on November 17, 2025. In your application, you requested zoning confirmation for the above referenced property and that “Critical Digital Infrastructure Facility” is an allowed use under the subject properties zoning.

The property referenced above is zoned General Industrial (GI).

§ 1-19-5.250. INDUSTRIAL ZONING DISTRICTS.

(A) The purpose of the industrial districts is to provide for the development of varied industrial uses that would supply needed employment opportunities for the county. Industrial development has inherent characteristics that require special attention and protection. Due regard must be given to industrial needs for adequate site locations with concentration on terrain, availability of water and sewer systems, transportation, and compatibility with surrounding development.

(C) The General Industrial District (GI) is intended to provide areas for industries involving manufacturing or processing and for those industrial uses which cannot meet the performance criteria of the Limited Industrial District.

CRITICAL DIGITAL INFRASTRUCTURE FACILITY. A facility consisting of one or more buildings used primarily for the storage, management, processing, and transmission of digital data, and which houses computer or network equipment, systems, servers, appliances, and other associated components related to digital data operations. The facility may also include customary accessory uses such as an office use, air handlers, power generators and storage, water cooling and storage facilities, and associated utility infrastructure needed to support sustained operations of the digital infrastructure.

A “Critical Digital Infrastructure Facility” is an allowed use within the General Industrial zoning district, subject to site plan approval as well as approval of all State of Maryland and Frederick County permits

As a resident of Frederick County, I am writing to express concern regarding recent inaccurate Zoning Verification Letters issued by the Frederick County Zoning Administrator to Rowan Digital Infrastructure. I believe these official communications convey specious information about the permissibility of Critical Digital Infrastructure facilities (data centers) under current county law. Such discrepancies not only risk misleading stakeholders and raise the issue of potential legal liability for the County, but also undermine the integrity of the ongoing legislative process of the CDI Overlay Zone. I urge you to evaluate this matter promptly and take corrective action to preserve public trust and democratic principles.

Zoning Verification Letter request V278266 was submitted on November 17, 2025, and replied to on December 12, 2025, for Lot 100 (Tax Map 94, Parcel 0070, Tax ID 01000152) at 5601 Manor Woods Road, Frederick, MD 21703. This lot (also referred to in other documents as "Bauxite VII") is part of the Quantum Frederick project on the former Eastalco site, but has not yet been developed. In his response letter, the Zoning Administrator writes to Rowan Digital Infrastructure: "This letter is in response to your zoning verification application submitted on November 17, 2025. In your application, you requested zoning confirmation for the above referenced property and that 'Critical Digital Infrastructure Facility' is an allowed use under the subject properties zoning" "A 'Critical Digital Infrastructure Facility' is an allowed use within the General Industrial zoning district, subject to site plan approval as well as approval of all State of Maryland and Frederick County permits. A review of the records in this office does not reflect any existing zoning violations at this Property at this time." (See attached letter, dated December 12, 2025, from Frederick County.)

As you know, this letter is incorrect because no new data centers are permitted at this time in Frederick County: Bill 25-09, which took effect on November 1, 2025, explicitly requires that CDI facilities be located on land zoned Limited Industrial (LI) or General Industrial (GI) **and within a designated CDI Overlay Zone**. Under § 1-19-5.310 (Use Table), CDI facilities are listed as a principal permitted use only when subject to site development plan approval **and within the CDI Overlay Zone**.

However, no such overlay zone(s) have been formally established or mapped to date. The Planning Commission has recommended limiting CDI development to specific areas, including portions around the former Eastalco site; but until boundaries are officially adopted and incorporated into the zoning map, the overlay requirement effectively prohibits any new CDI approvals countywide for applications filed after the effective date. The public hearing on this

issue is scheduled for December 16, 2025, with a potential Council vote on December 23. Until these required steps are completed, no property in the county qualifies under the CDI-OZ designation. Therefore, this zoning verification is incomplete – and noncompliant with the current code, as it fails to address the mandatory CDI Overlay Zone requirement.

A public search via the County permitting portal further shows similar Zoning Verification Letters (see table below) were requested by Rowan in November 2025 and issued last week by the County for Lots 202, 203, 204, and 301, with one new letter now pending for Lot 112c. All of these letters overlook the restrictions imposed by Bill 25-09, which should apply to all post-effective-date applications.

Of further note, a “Bauxite VII” site plan for Lot 100 (SP287201) was submitted on November 1, 2025, proposing two new data center buildings, an auxiliary water building, and affiliated stormwater management, infrastructure, and security improvements. The Permit Office's decision to void this application on November 3, 2025, specifically noting the absence of a currently designated CDI Overlay Zone, as well as voiding SP278204 for Bauxite II (2nd Revision), which proposed data center expansions on Lot 302, was entirely consistent with the law. This raises an important question: Why did the County deviate from this earlier precedent and instead agree to issue letters last week, incorrectly affirming the current permissibility of new CDI use for five Quantum/Rowan lots?

The recent issuance of these Zoning Letters is troubling. Any Frederick County citizen learning about these documents might reasonably conclude that the County has already sanctioned data center development on these properties, preempting the decisions now ostensibly slated for public debate and Council deliberation. This perception renders the public hearing on December 16th superfluous, diminishes the value of community input, and erodes the transparency

essential to our democratic process. It further suggests undue haste to facilitate development before the legislative framework is finalized, potentially fostering inconsistencies in enforcement and public mistrust.

To safeguard the legitimacy of this process, the Zoning Administrator should immediately retract these inaccurate letters, and the County should cease efforts to facilitate data center development until the CDI Overlay Zone boundaries are formally adopted. Such reasonable measures would reaffirm the County's commitment to fair, accountable governance and ensure that decisions of this magnitude accurately reflect the will of the community impacted by this portentous matter.

I look forward to your response and to participating in the public hearing.

I just don't think the scale, the size, and impact, of what is being proposed are firmly and universally understood and communicated. I worry, in fact, that the board is failing to hold a strong perspective relative to what is about to be approved. According to the county council, they are committed to avoiding the "sprawl" plainly exists in Virginia at this point. That is great. But "sprawl" is not just about the physical footprint of a building.

True, data centers are HUGE. According to county documents, if the new site is approved and built to capacity, it will have approval to create data centers covering about 20 MILLION square feet of space. Again, just to put this in perspective, if built as a single square, such a structure would be about 9 tenths of a mile long and 9 tenths of a mile wide, and would probably be a hundred or so feet tall. But even such a monstrous eyesore is not the point.

That is because there is another sort of "sprawl" that the new site will inflict on us all.

It would use approximately the same amount of water as the entire city of Frederick every day. It would use electricity at a rate equal to that of 30,000 homes and its use would be constant -- all day, all night (and with hundreds of backup diesel generators that would kick in during power outages). And while it consumes those resources, it would only generate the same amount of tax revenue for the county as about 2,700 homes similar to the one I live in. And it would create a number of jobs that is (generously, in my view) estimated to be on the order of 1700.

I offer that someone somewhere is perhaps failing to appreciate the true size of what they are about to agree to, the water resources that are about to be consumed, and the impact on the electricity demand that will result in higher costs for us all. That someone may also be confused about the number of jobs that may result.

I recommend that any approval for a data center in Frederick county be given only when these perspectives of scale, cost, and impact, are addressed such that there will be a much lower impact on the county's human residents than is currently the case. So, please note, in spite of all of the above, I don't object to the idea of new data centers. What I struggle with is the impact that will be foisted onto us by it not being made to pay its share of that impact that it will surely cause to us all.

There are creative ways to solve that. I urge those ways to be explored.

What happened to solar for power, and battery storage for backup power? What happened to thinking about building underground? What happened to using technology to recycle water? None of these things are on the table because they are more expensive than having the residents of this

county suffer instead. This is a boondoggle for the extremely wealthy companies that want the data centers.

Please push back. Make them come up with plans that don't hurt the families that live here.
